## **Manufacturing Site Relocation**

Riverside, California — January 10, 2024 — Bourns has learned that a certain Bourns' sub-supplier was added to the Uyghur Forced Labor Prevention Act Entity List (the "UFLPA List") by the United States Department of Homeland Security ("DHS").

This sub-supplier is contesting its inclusion on the UFLPA List and is working with its legal team to provide required documentation for removal from the UFLPA List.

Before the US Uyghur Forced Labor Prevention Act came into effect on June 21, 2022, Bourns did its due diligence in investigating and documenting compliance of its supply chain. Bourns has a signed certificate from the affected sub-supplier to support prior purchases. Bourns had also dispatched its audit team to the sub-supplier's plant to audit labor used in manufacturing to make sure that no persecuted ethnic minority employees were employed on conditions supporting finding of forced labor.

In compliance with United States and other applicable laws and keeping with Bourns' Code of Ethics and Conduct, Bourns immediately stopped all purchases from the sub-supplier and all shipments of Bourns® products containing materials from this sub-supplier.

To minimize production disruption for our customers due to this sub-supplier related stop purchase and stop ship, effective January 22, 2024, the manufacturing site for the <u>Bourns® Model PAD001/002</u>, <u>PS13005</u>, <u>PT131xxL</u>, <u>PT610xxPEL</u>, <u>PT76787PEL</u>, <u>SM13xxxEL/XEL/CEL/PEL</u>, <u>SM51xxxPEL/EL and SM75xxxPEL Series SMD Transformers</u> will be relocated to another manufacturing facility.

The affected part numbers produced at the new manufacturing location will meet the same data sheet specifications.

The form, fit, function, quality, reliability and country of origin of the affected parts as standalone components will remain the same.

Samples are available upon request. Bourns recommends that customers test the affected part numbers in their specific applications for verification of satisfactory performance in customers' applications.

Traceability will be maintained through lot code and date code.
