1. Purpose

To improve production efficiency and better serve our customers in the globe, the production line of CD series will be re-located from our China factory to Hanoi, Vietnam. This move will take around several months and the mass production is schedule to be readied in Mar 2024 or earlier.

C&K have put in place several actions to minimize potential disruption caused by this move. Safety stock levels has been prepared to cover the transition period, so we can continue shipments with minimal disruption.

This notification is to inform of the manufacturing location transfer from China to Vietnam with continuous improvements.
