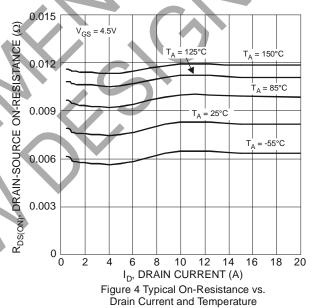

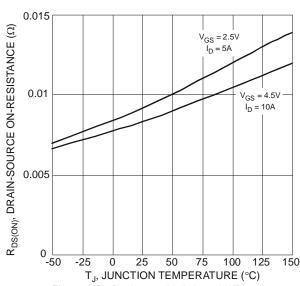


Figure 6 On-Resistance Variation with Temperature



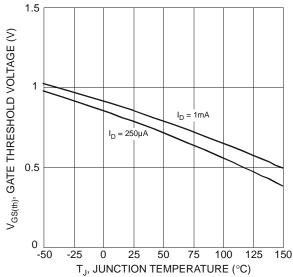
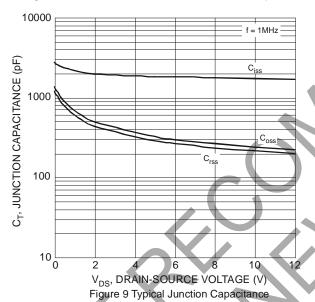
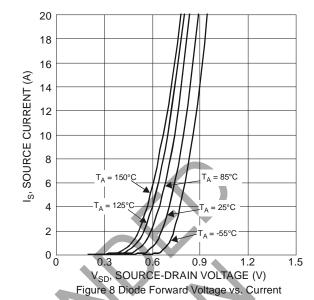
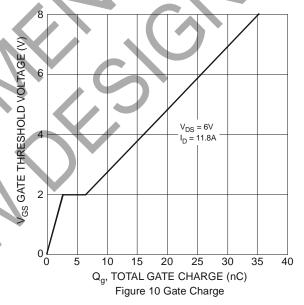


Figure 7 Gate Threshold Variation vs. Ambient Temperature







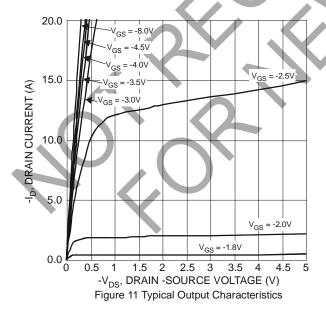


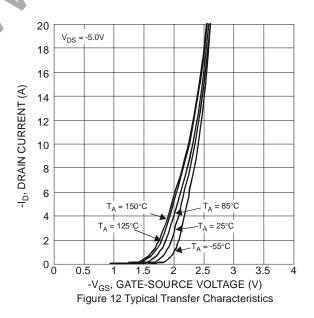

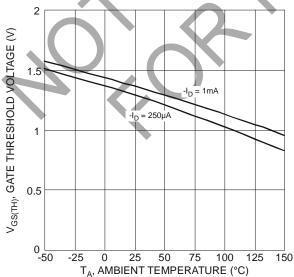
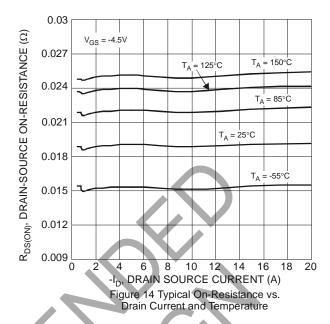
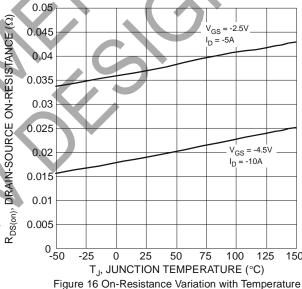


Figure 17 Gate Threshold Variation vs. Ambient Temperature

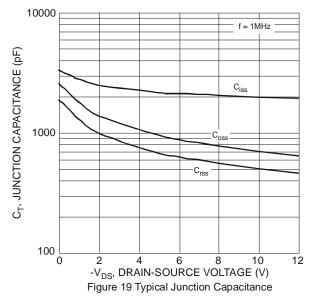


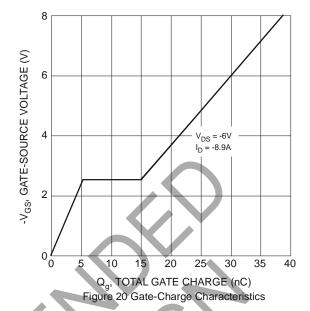


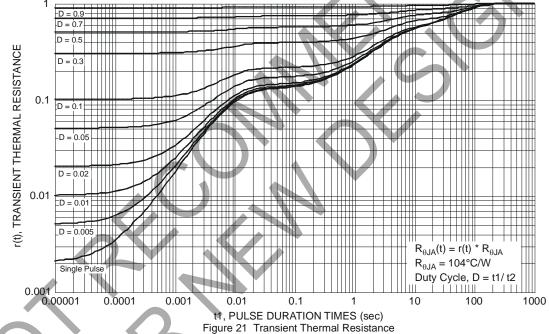

Figure 18 Diode Forward Voltage vs. Current





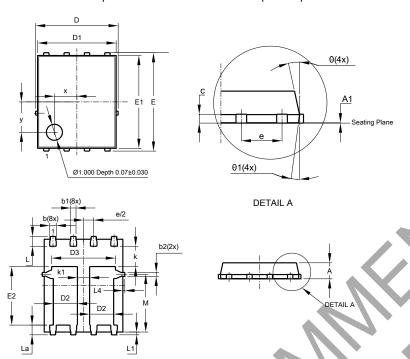

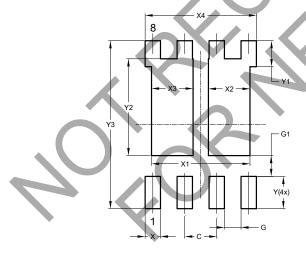
