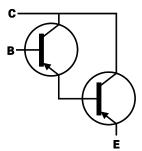

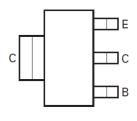

Top View Pin-Out

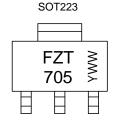

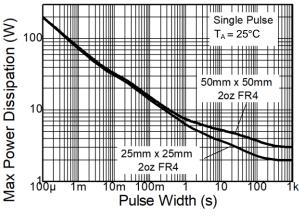

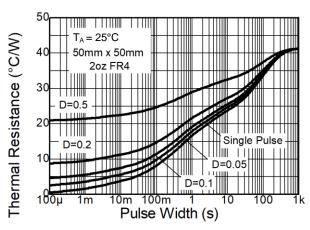
Safe Operating Area FZT705



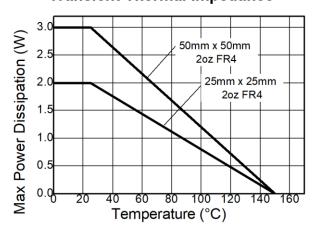
### **Transient Thermal Impedance**

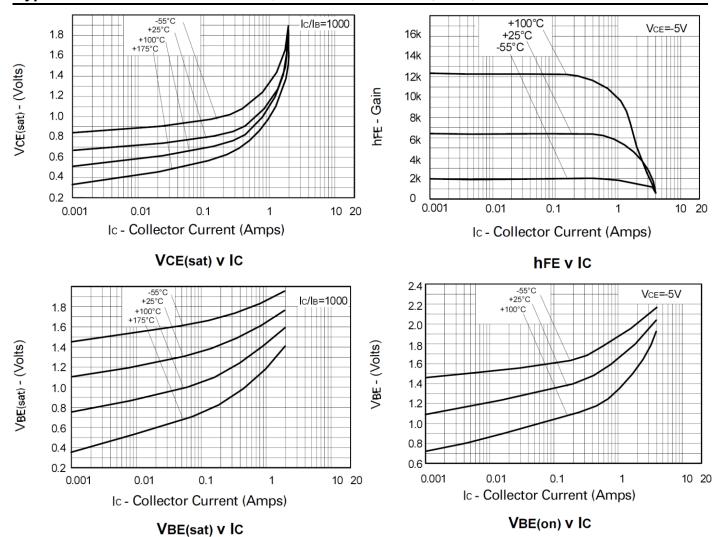

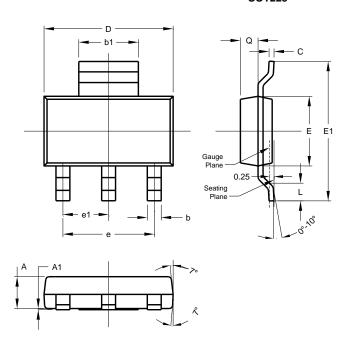

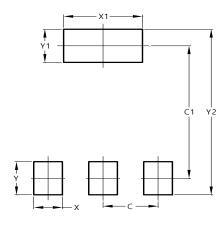
