


Figure 1. Typical Forward Characteristics





Figure 3. Total Capacitance vs. Reverse Voltage



1 25 50 75 100 125 150 T<sub>C</sub>, CASE TEMPERATURE (°C)


Figure 4. DC Forward Current Derating


