1. SCOPE

- * 1.1 Scope. This specification covers the performance requirements for PNP, silicon, radiation hardened, low-power amplifier, and switching transistors. Four levels of product assurance are provided for each encapsulated device (JAN, JANTX, JANTXV, and JANS) and two levels of product assurance are provided for unencapsulated die (JANHC and JANKC).

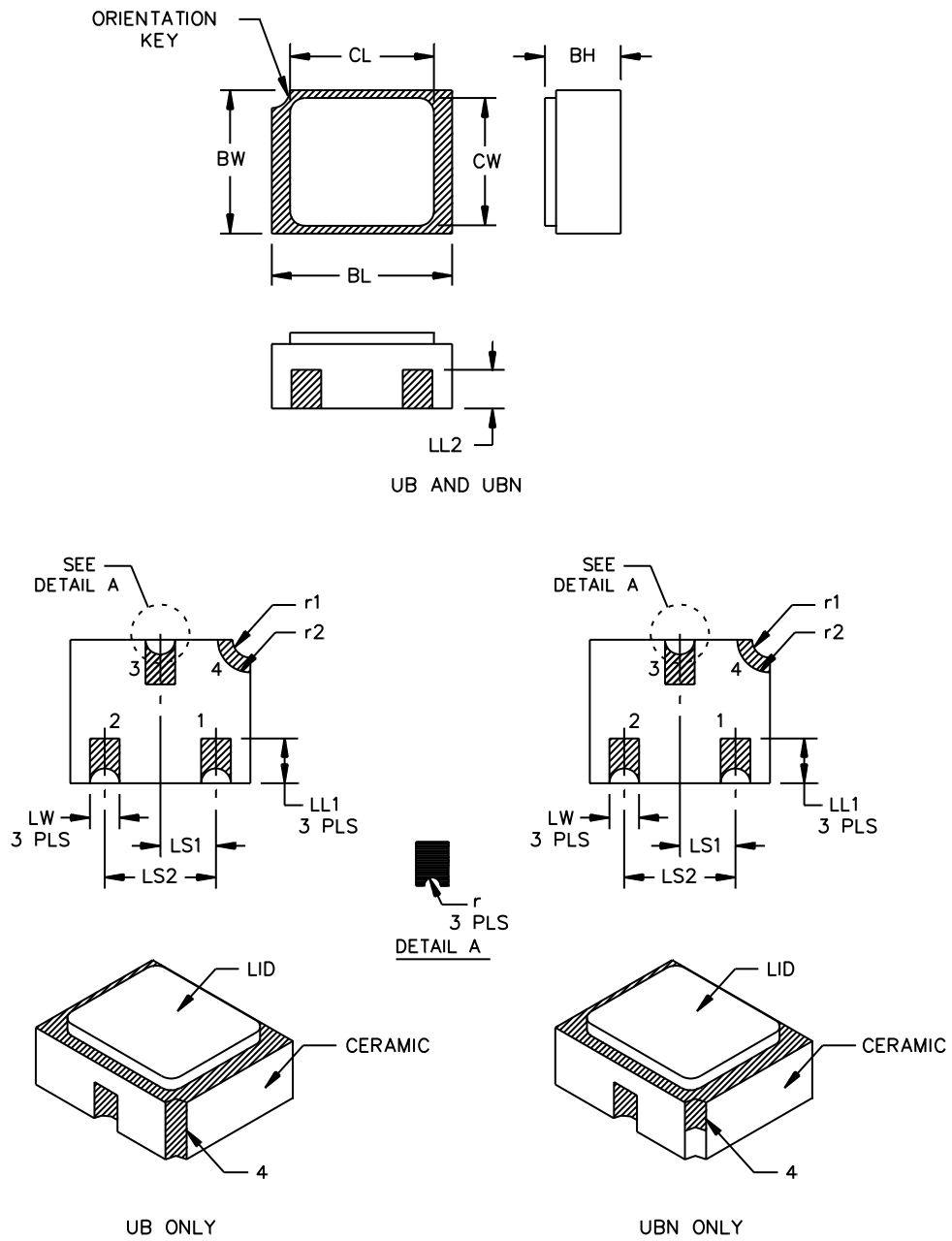


FIGURE 2. Physical dimensions, surface mount 2N3634UB through 2N3637UB (UB and UBN version).

- * 1.2 Package outlines and die topography. The device package for the encapsulated device type are as follows: TO-5 and TO-39 in accordance with [figure 1](#), surface mount version in accordance with [figure 2](#). The dimensions and topography for JANHC and JANKC unencapsulated die are as follows: "A" version die in accordance with [figure 3](#), "B" version die in accordance with [figure 4](#), and "C" version die in accordance with [figure 5](#).

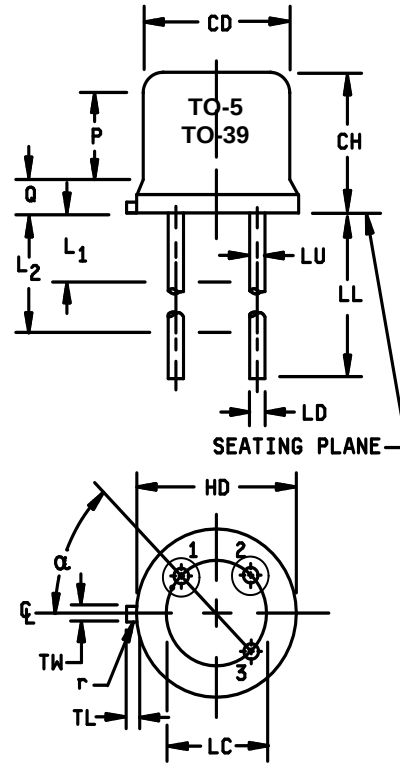

The "UBN" suffix has an isolated metal lid where the "UB" suffix does not.

FIGURE 1. Physical dimensions (TO-5 and TO-39).

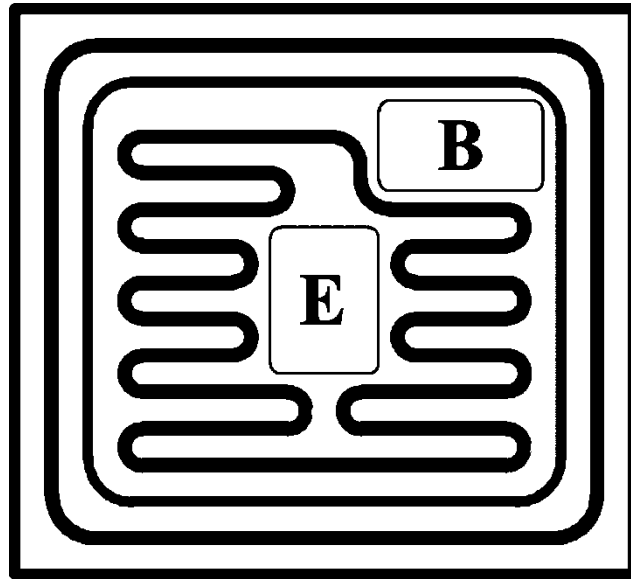

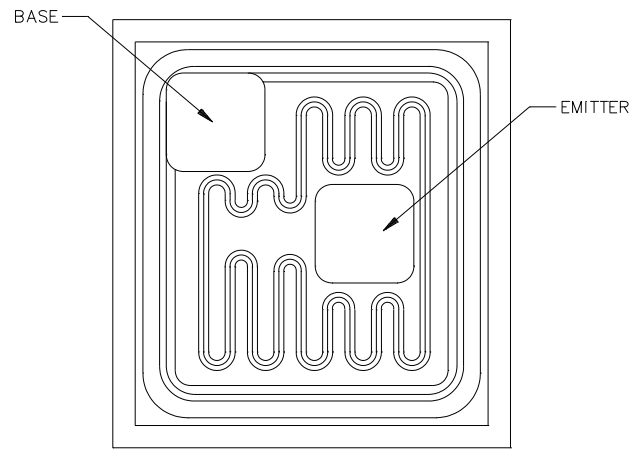
FIGURE 2. Physical dimensions, surface mount 2N3634UB through 2N3637UB (UB and UBN version).

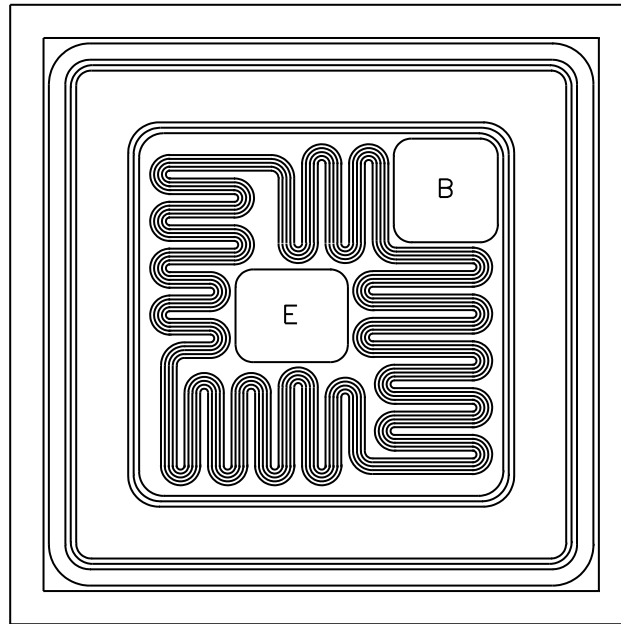
FIGURE 3. JANHCA and JANKCA die dimensions.

2.3 Order of precedence. Unless otherwise noted herein or in the contract, in the event of a conflict between the text of this document and the references cited herein, the text of this document takes precedence. Nothing in this document, however, supersedes applicable laws and regulations unless a specific exemption has been obtained.

3. REQUIREMENTS

3.1 General. The individual item requirements shall be as specified in **MIL-PRF-19500** and as modified herein.

3.2 Qualification. Devices furnished under this specification shall be products that are manufactured by a manufacturer authorized by the qualifying activity for listing on the applicable qualified manufacturers list before contract award (see 4.2 and 6.3).

3.3 Abbreviations, symbols, and definitions. Abbreviations, symbols, and definitions used herein shall be as specified in **MIL-PRF-19500** and as follows.

$R_{\theta JSP(AM)}$ Thermal resistance junction to solder pads (adhesive mount to PCB).

$R_{\theta JSP(IS)}$ Thermal resistance junction to solder pads (infinite sink mount to PCB).

3.4 Interface and physical dimensions. The interface and physical dimensions shall be as specified in **MIL-PRF-19500** and on figures 1, 2, 3, 4, and 5.

3.4.1 Lead finish. Lead finish shall be solderable in accordance with **MIL-PRF-19500**, **MIL-STD-750**, and herein. Where a choice of lead finish is desired, it shall be specified in the acquisition document (see 6.2).

3.5 Radiation hardness assurance (RHA). Radiation hardness assurance requirements, PIN designators, and test levels shall be as defined in **MIL-PRF-19500**.

3.6 Electrical performance characteristics. Unless otherwise specified herein, the electrical performance characteristics are as specified in 1.3, 1.4, and table I.

3.7 Electrical test requirements. The electrical test requirements shall be as specified in table I herein.

3.8 Marking. Marking shall be in accordance with MIL-PRF-19500. The radiation hardened designator M, D, P, L, R, F, G, or H shall immediately precede (or replace) the device "2N" identifier (depending upon degree of abbreviation required).

3.9 Workmanship. Semiconductor devices shall be processed in such a manner as to be uniform in quality and shall be free from other defects that will affect life, serviceability, or appearance.

4. VERIFICATION

4.1 Classification of inspections. The inspection requirements specified herein are classified as follows:

- a. Qualification inspection (see 4.2).
- b. Screening (see 4.3).
- c. Conformance inspection (see 4.4 and tables I and II).

4.2 Qualification inspection. Qualification inspection shall be in accordance with MIL-PRF-19500 and as specified herein.

4.2.1 JANHC and JANKC qualification. JANHC and JANKC qualification inspection shall be in accordance with MIL-PRF-19500.

4.2.2 Group E qualification. Group E inspection shall be performed for qualification or requalification only. In case qualification was awarded to a prior revision of the specification sheet that did not request the performance of table III tests, the tests specified in table III herein that were not performed in the prior revision shall be performed on the first inspection lot to this revision to maintain qualification.

* 4.3 Screening.

- * 4.3.1 Screening of encapsulated devices (JANTX, JANTXV, and JANS levels only). Screening shall be in accordance with table E-IV of [MIL-PRF-19500](#), and as specified herein. The following measurements shall be made in accordance with [table I](#) herein. Devices that exceed the limits of [table I](#) herein shall not be acceptable.

- (1) Shall be performed anytime after temperature cycling, screen 3a; JANTX and JANTXV levels do not need to be repeated in screening requirements.

- * 4.3.2 Screening of unencapsulated die (JANHNC and JANKC). Screening of JANHC and JANKC unencapsulated die shall be in accordance with appendix G of [MIL-PRF-19500](#). The burn-in duration for JANKC level shall follow the JANS requirements; the JANHC level shall follow the JANTX requirements of table E-IV of [MIL-PRF-19500](#).

4.3.3 Power burn-in conditions. Power burn-in conditions are as follows: $V_{CB} = 10 - 30$ V dc. Power shall be applied to achieve $T_J = +135^\circ\text{C}$ minimum using a minimum $P_D = 75$ percent of P_T maximum rated as defined in 1.3. With approval of the qualifying activity and preparing activity, alternate burn-in criteria (hours, bias conditions, T_J , and mounting conditions) may be used for JANTX and JANTXV quality levels. A justification demonstrating equivalence is required. In addition, the manufacturing site's burn-in data and performance history will be essential criteria for burn-in modification approval.

4.3.4 Thermal impedance ($Z_{\theta JX}$ measurements). The $Z_{\theta JX}$ measurements shall be performed in accordance with method 3131 of [MIL-STD-750](#) using the guidelines in that method for determining I_M , I_H , t_H , t_{MD} (and V_C where appropriate). (See figures 10 through 12.) Measurement delay time (t_{MD}) = 70 μs maximum. See [table III](#), group E, subgroup 4 herein.

4.4 Conformance inspection. Conformance inspection shall be in accordance with [MIL-PRF-19500](#) and as specified herein. If alternate screening is being performed in accordance with MIL-PRF-19500, a sample of screened devices shall be submitted to and pass the requirements of [table I](#), group A, subgroup 1, subgroup 2 inspection only.

4.4.1 Group A inspection. Group A inspection shall be conducted in accordance with table E-V of [MIL-PRF-19500](#) and [table I](#) herein.

- * 4.4.2 Group B inspection. Group B inspection shall be conducted in accordance with the conditions specified for subgroup testing in table E-VIA (JANS) of [MIL-PRF-19500](#) and [4.4.2.1](#) herein. Delta requirements shall be in accordance with [4.5.4](#) herein. See [4.4.2.2](#) for JAN, JANTX, and JANTXV group B testing. Delta requirements for JAN, JANTX, and JANTXV shall be after each step in [4.4.2.2](#) and shall be in accordance with [4.5.4](#) herein.

4.4.2.2 Group B inspection, table E-VIb (JAN, JANTX, and JANTXV) of [MIL-PRF-19500](#). Separate samples may be used for each step. In the event of a lot failure, the resubmission requirements of MIL-PRF-19500 shall apply. In addition, all catastrophic failures during CI shall be analyzed to the extent possible to identify root cause and corrective action. Whenever a failure is identified as wafer lot and /or wafer processing related, the entire wafer lot and related devices assembled from the wafer lot shall be rejected unless an appropriate determined corrective action to eliminate the failures mode has been implemented and the devices from the wafer lot are screened to eliminate the failure mode.

4.4.2.3 Group B sample selection. Samples selected from group B inspection shall meet all of the following requirements:

- a. For JAN, JANTX, and JANTXV samples shall be selected randomly from a minimum of three wafers (or from each wafer in the lot) from each wafer lot. For JANS, samples shall be selected from each inspection lot. See [MIL-PRF-19500](#).
- b. Shall be chosen from an inspection lot that has been submitted to and passed [table I](#), subgroup 2, conformance inspection. When the final lead finish is solder or any plating prone to oxidation at high temperature, the samples for life test (subgroups B4 and B5 for JANS, and group B for JAN, JANTX, and JANTXV) may be pulled prior to the application of final lead finish.

* 4.4.3 Group C inspection. Group C inspection shall be conducted in accordance with the test and conditions specified for subgroup testing in table E-VII of [MIL-PRF-19500](#), and in [4.4.3.1](#) (JANS) and [4.4.3.2](#) (JAN, JANTX, and JANTXV) herein for group C testing. Delta requirements only apply to subgroup C6 and shall be in accordance with [4.5.4](#) herein.

4.4.3.3 Group C sample selection. Samples for subgroups in group C shall be chosen at random from any inspection lot containing the intended package type and lead finish procured to the same specification which is submitted to and passes [table I](#) tests herein for conformance inspection. When the final lead finish is solder or any plating prone to oxidation at high temperature, the samples for C6 life test may be pulled prior to the application of final lead finish. Testing of a subgroup using a single device type enclosed in the intended package type shall be considered as complying with the requirements for that subgroup.

4.4.4 Group D inspection. Conformance inspection for hardness assured JANS and JANTXV types shall include the group D tests specified in [table II](#) herein. These tests shall be performed as required in accordance with [MIL-PRF-19500](#) and method 1019 of [MIL-STD-750](#), for total ionizing dose or method 1017 of [MIL-STD-750](#) for neutron fluence as applicable (see [6.2](#) herein), except group D, subgroup 2 may be performed separate from other subgroups. Alternate package options may also be substituted for the testing provided there is no adverse effect to the fluence profile.

4.4.5 Group E inspection. Group E inspection shall be conducted in accordance with the conditions specified for subgroup testing in appendix E, table E-IX of MIL-PRF-19500 and as specified herein. Electrical measurements (end-points) shall be in accordance with subgroup 2 of table I and 4.5.4 herein.

4.5 Method of inspection. Methods of inspection shall be as specified in the appropriate tables and as follows.

4.5.1 Pulse measurements. Conditions for pulse measurement shall be as specified in section 4 of MIL-STD-750.

4.5.2 Input capacitance. This test shall be conducted in accordance with method 3240 of MIL-STD-750, except the output capacitor shall be omitted.

4.5.3 Noise figure. Noise figure shall be measured using a model 310B Quan Tech Laboratories test set, or equivalent. Conditions shall be as specified in table I herein.

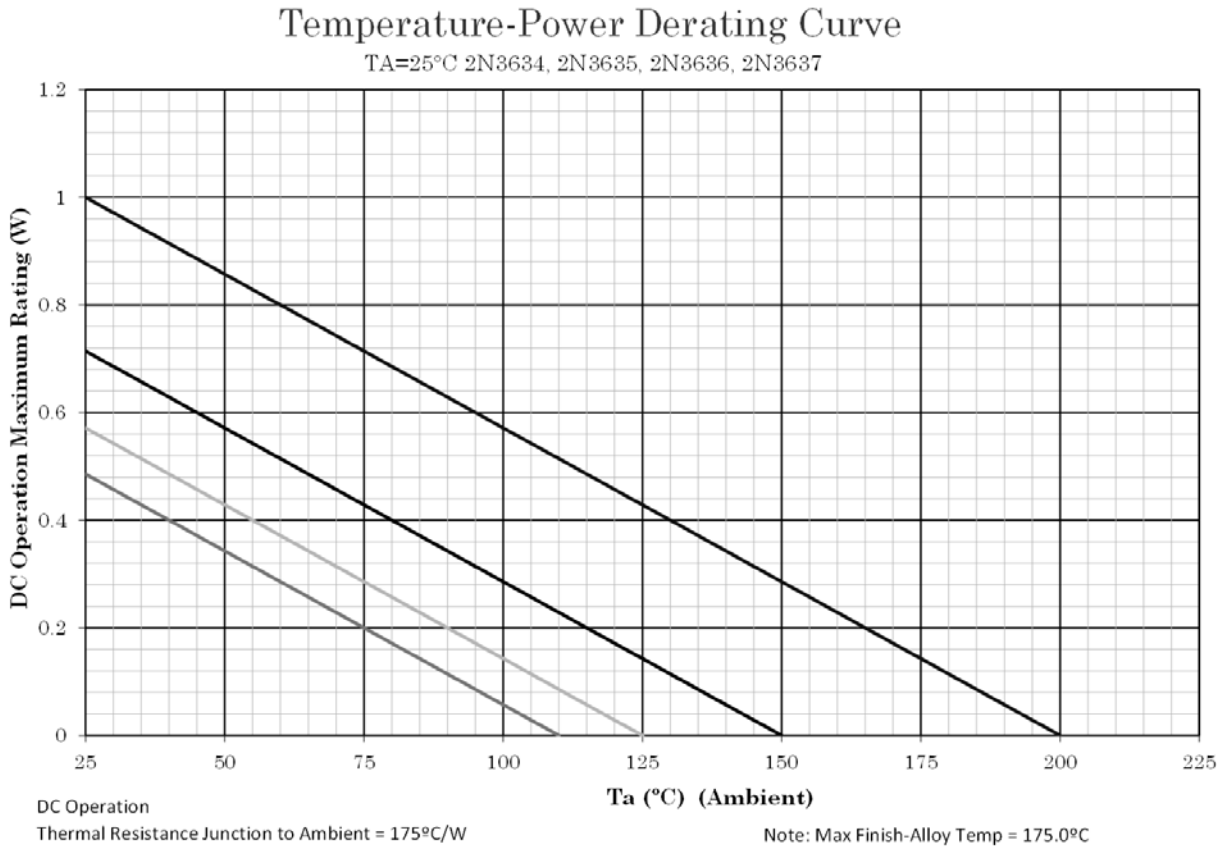

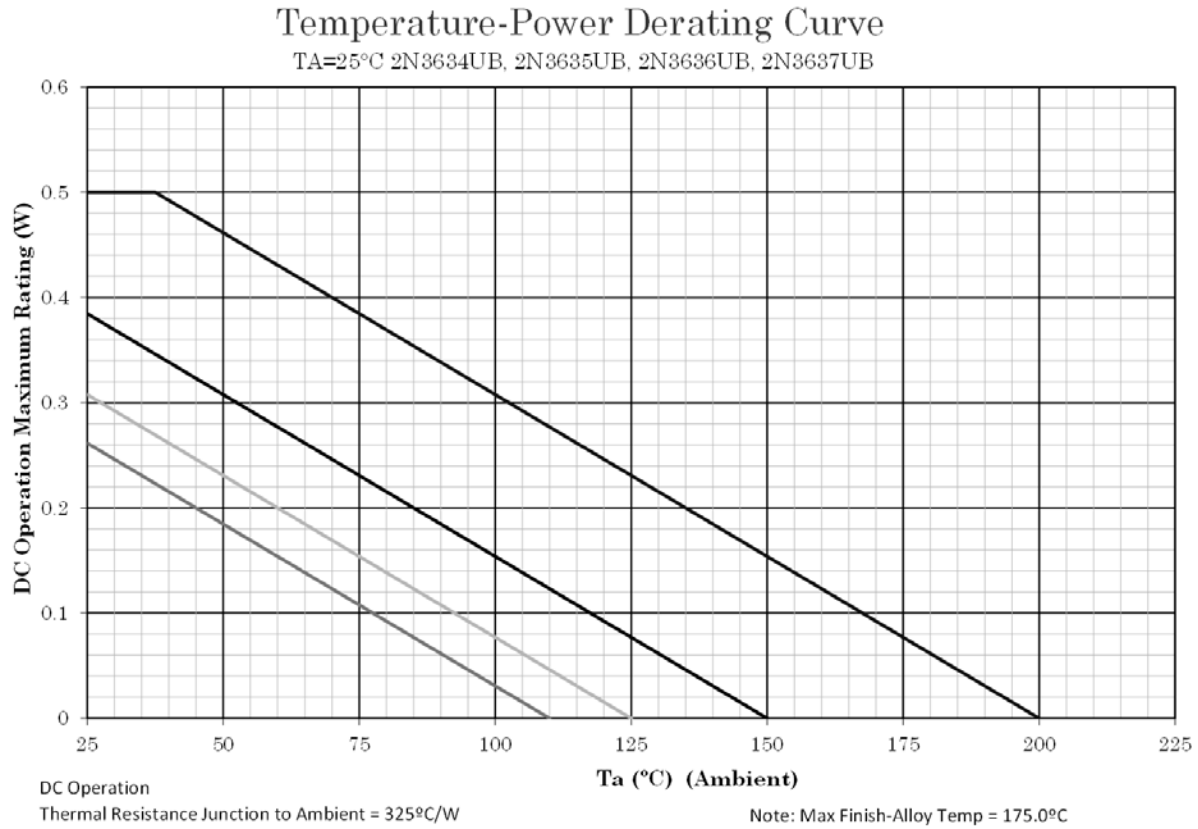

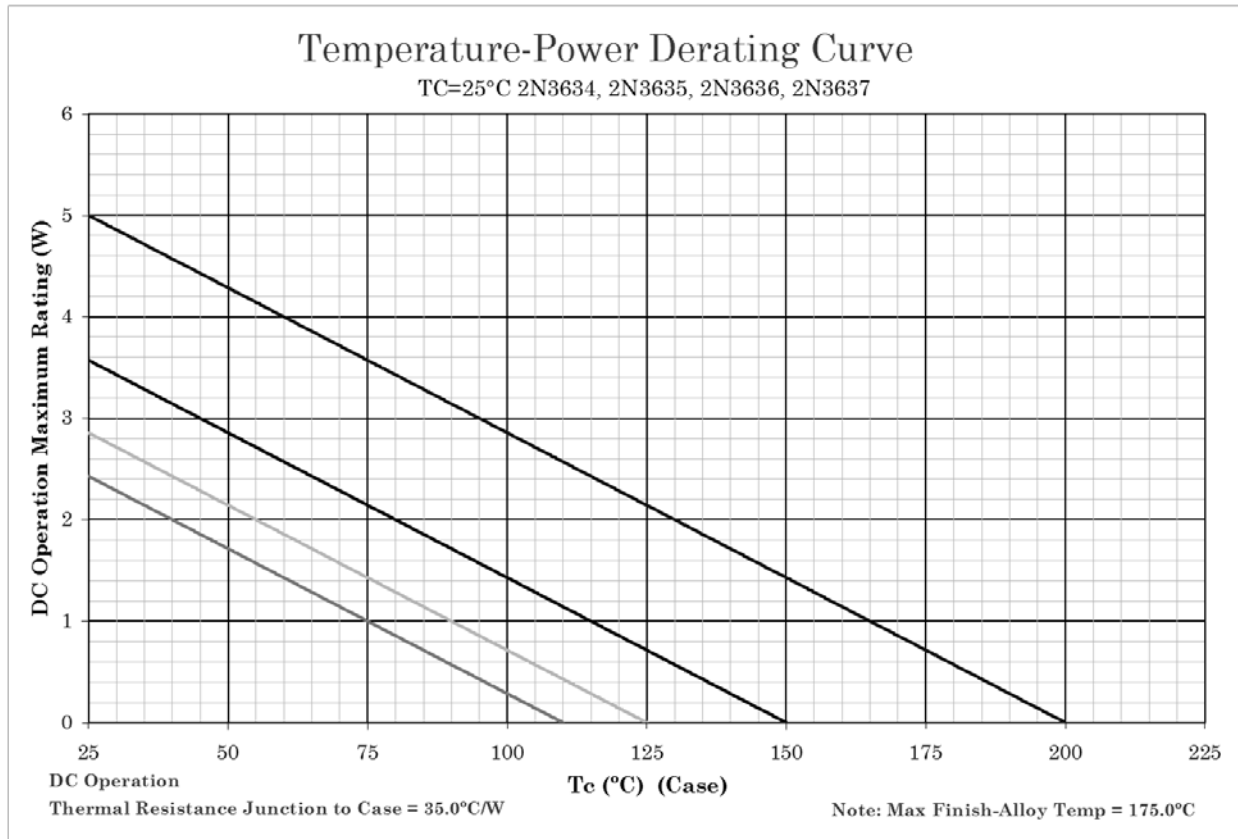
FIGURE 6. Temperature-power derating for ($R_{\theta JA}$), base case mount (TO-5 and TO-39).

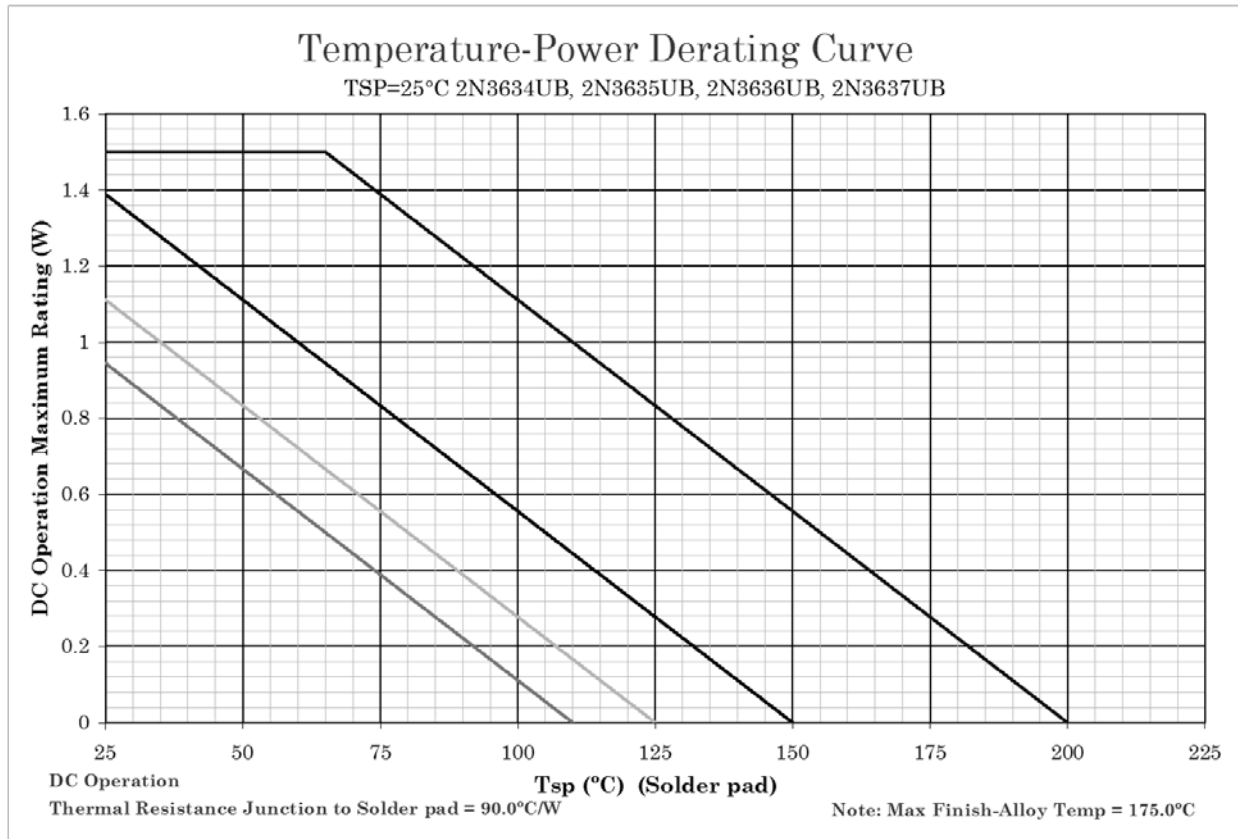
FIGURE 7. Temperature-power derating for ($R_{\theta JA}$) (UB AND UBN).

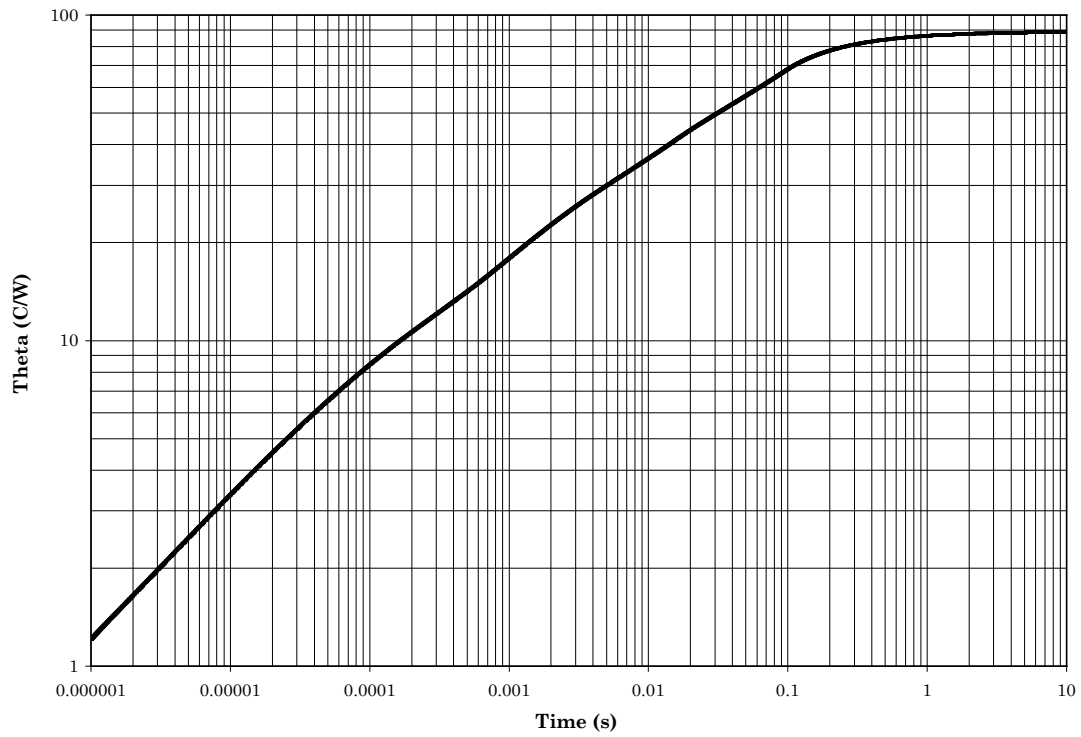
FIGURE 8. Temperature-power derating for ($R_{\theta JC}$), base case mount (TO-5 and TO-39 Kovar).

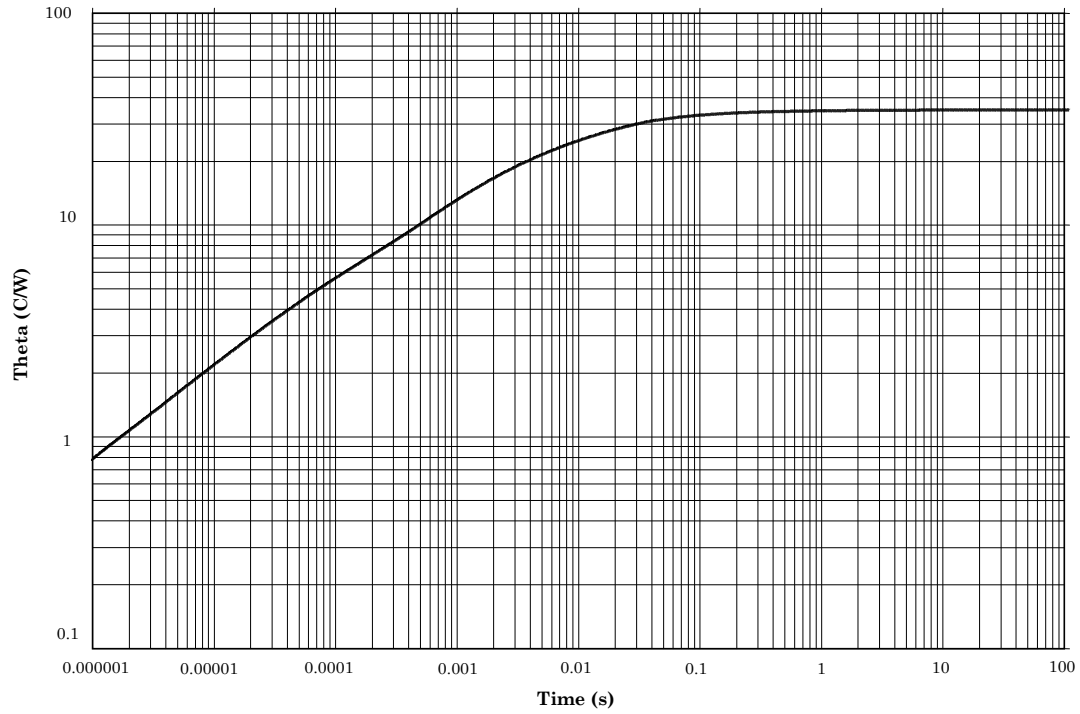
FIGURE 9. Temperature-power derating for ($R_{\theta JSP}$), base case mount (UB AND UBN).

FIGURE 10. Thermal impedance graph ($R_{\theta JSP}$) for 2N3634UB through 2N3637UB (UB AND UBN).

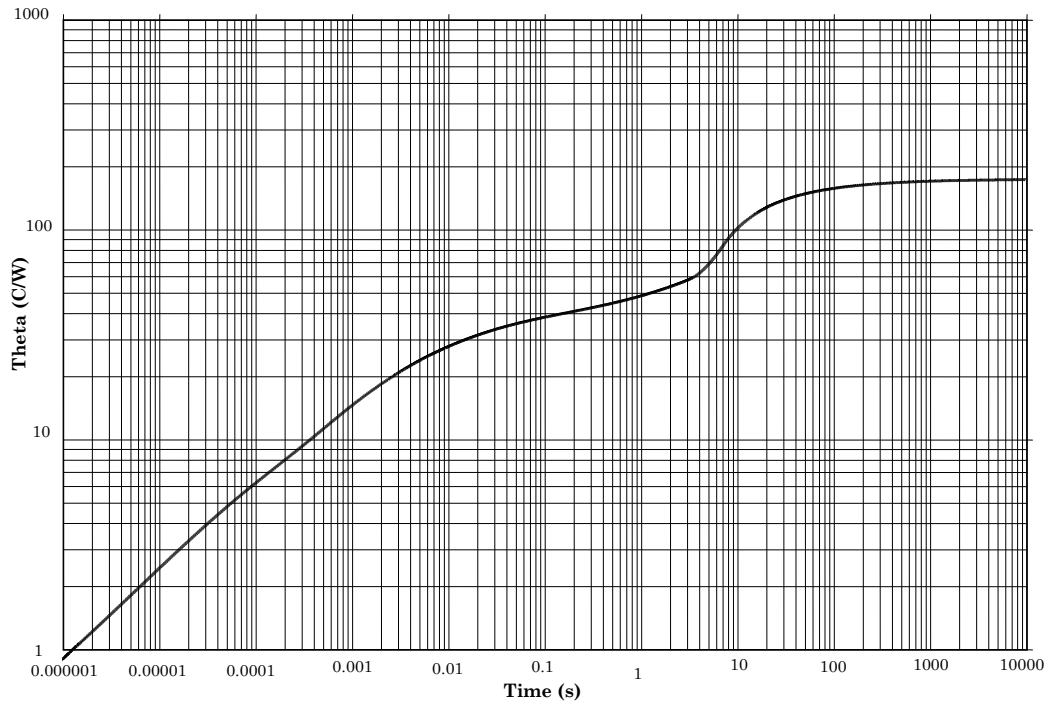
Maximum Thermal Impedance



$T_C = +25^\circ\text{C}$, thermal resistance $R_{\theta JC} = 35^\circ\text{C/W}$ (ambient case mount).

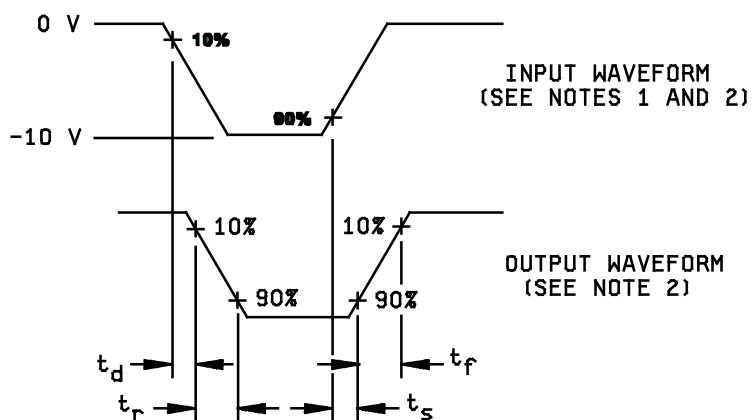
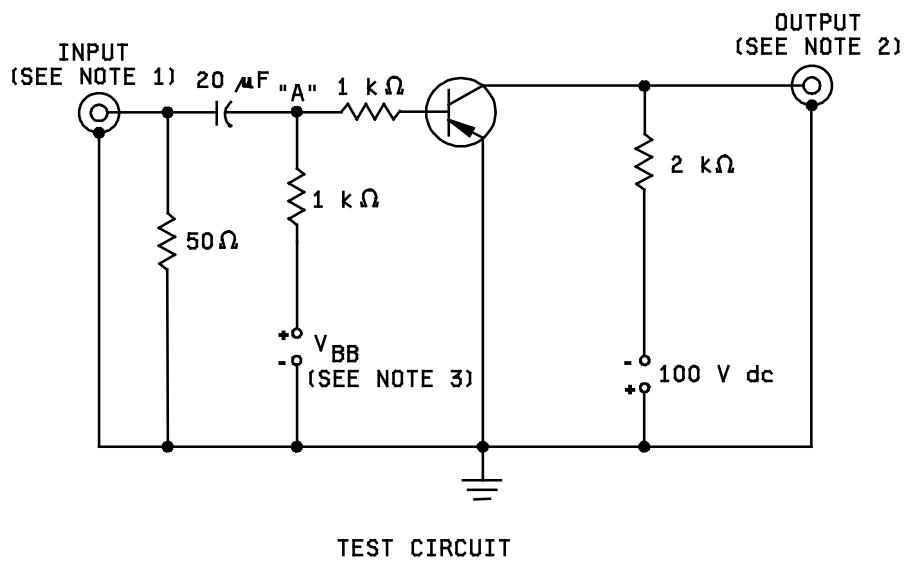
FIGURE 11. Thermal impedance graph ($R_{\theta JC}$) for 2N3634 through 2N3637 and 2N3634L through 2N3637L (TO-5 and TO-39 Kovar).

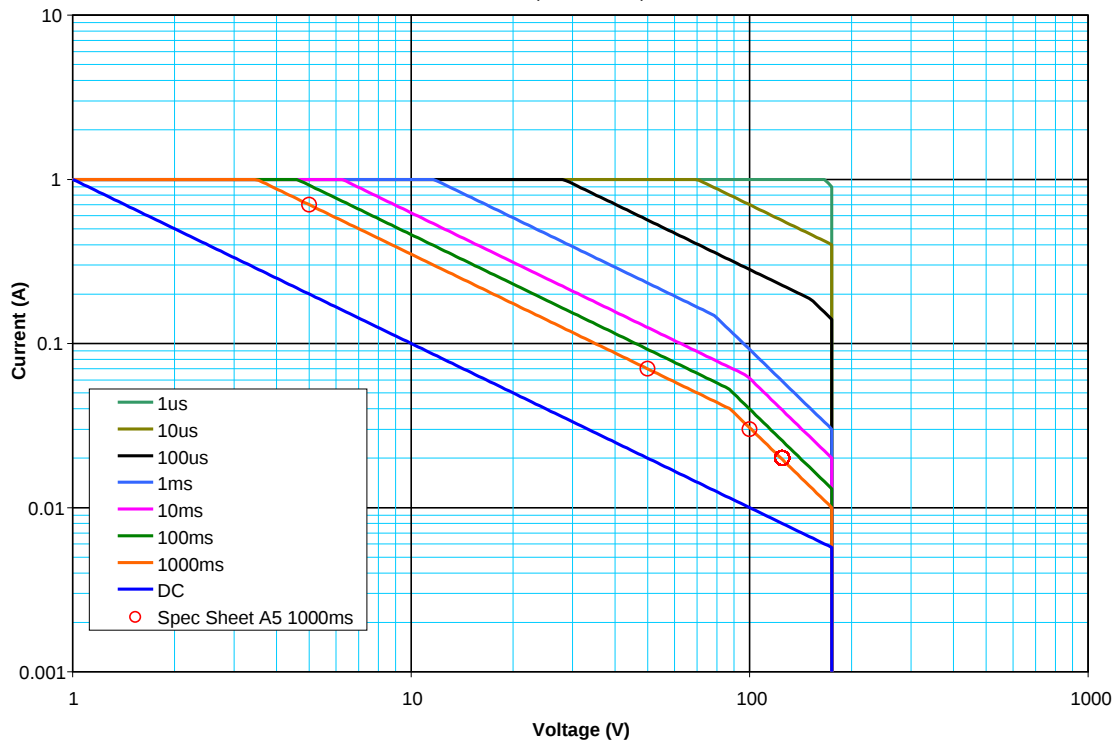
FIGURE 12. Thermal impedance graph ($R_{\theta JA}$) for 2N3634 through 2N3637 and 2N3634L through 2N3637L (TO-5 and TO-39).

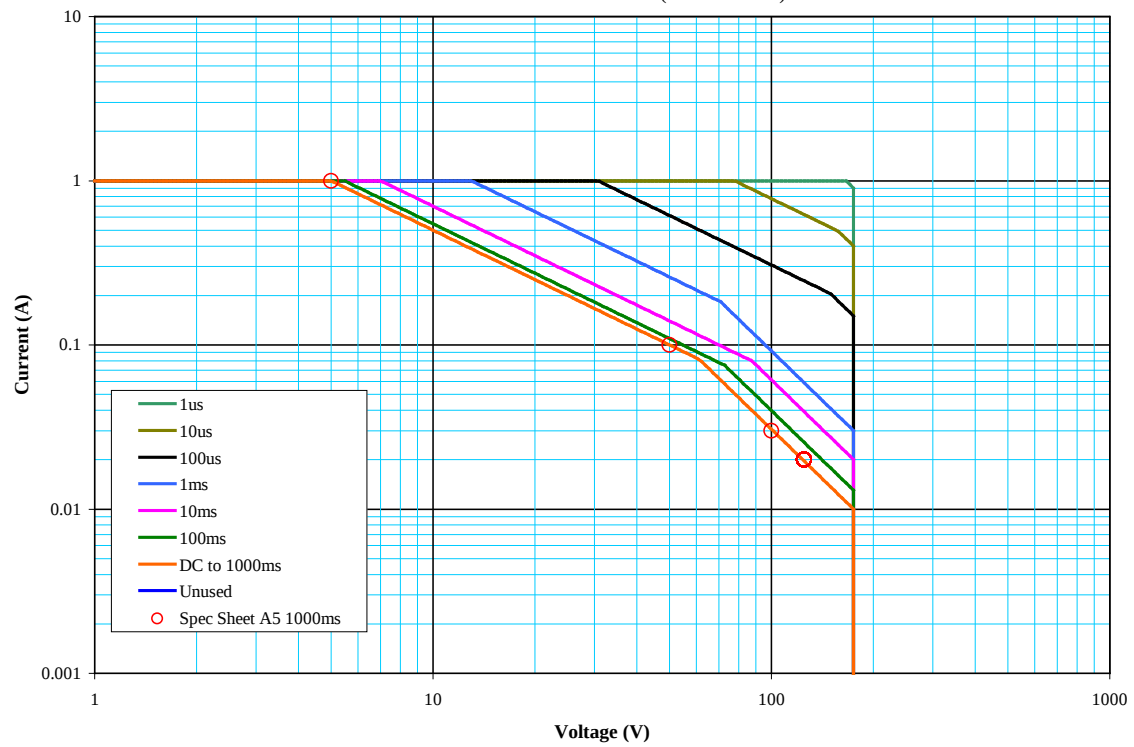


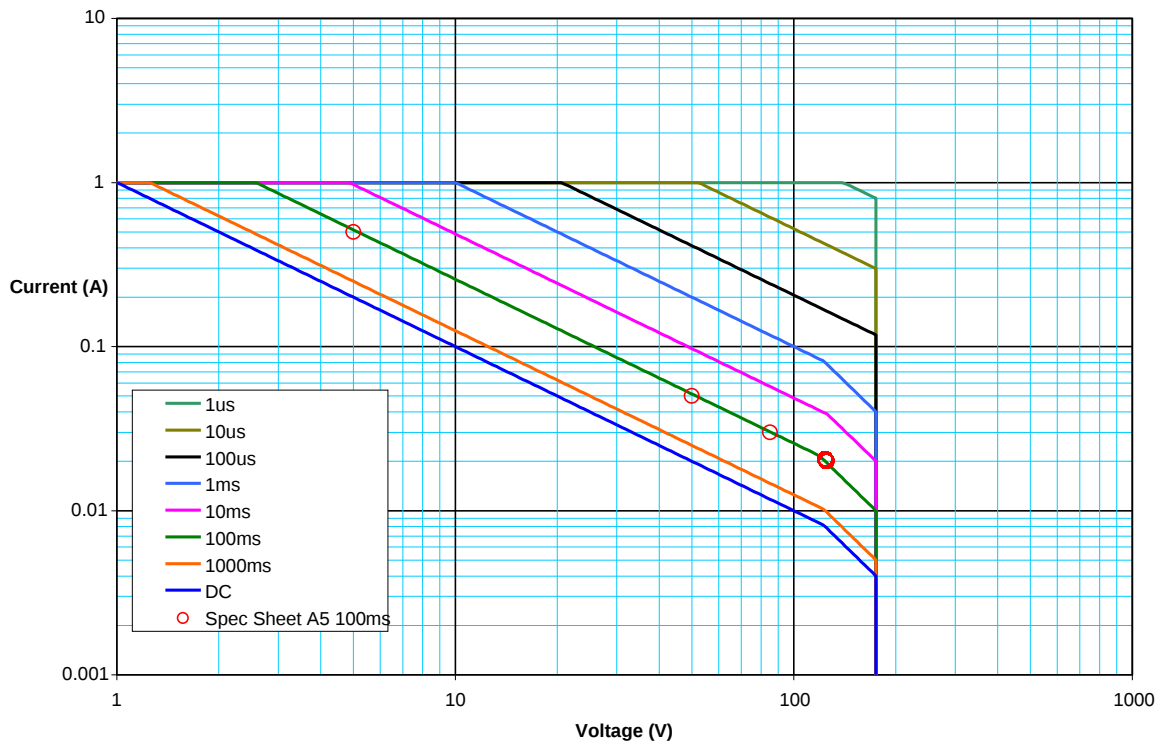

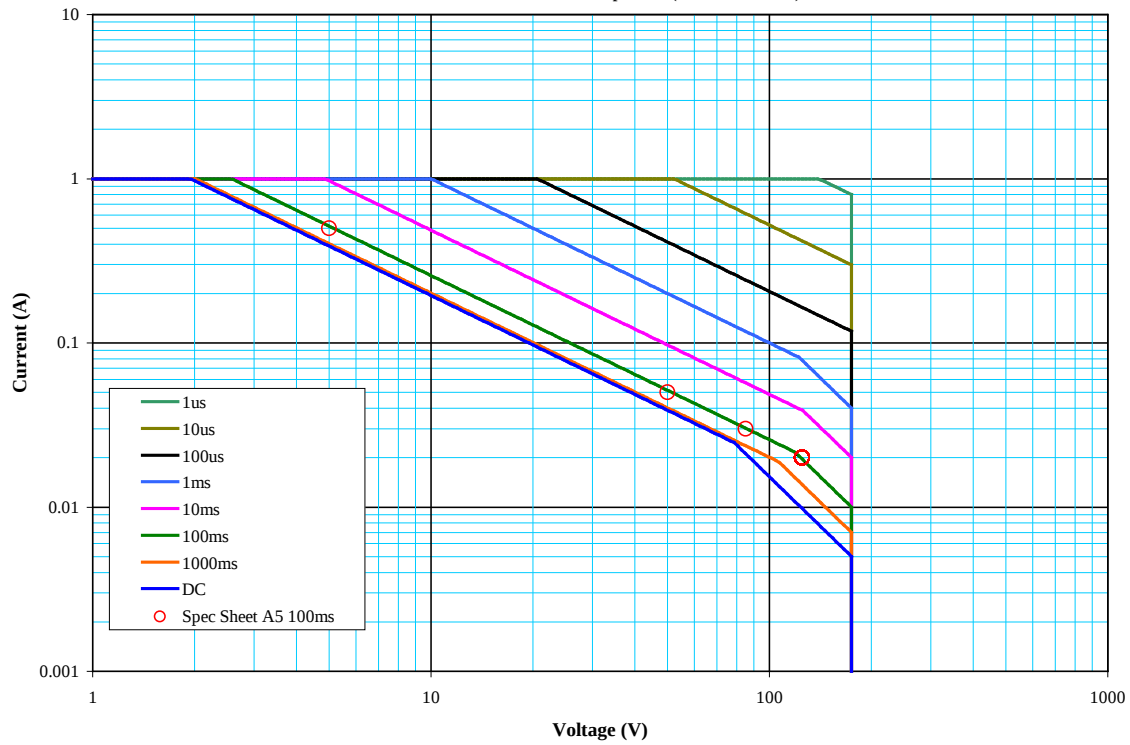

5. PACKAGING

5.1 Packaging. For acquisition purposes, the packaging requirements shall be as specified in the contract or order (see 6.2). 6.2 Acquisition requirements. Acquisition documents should specify the following:

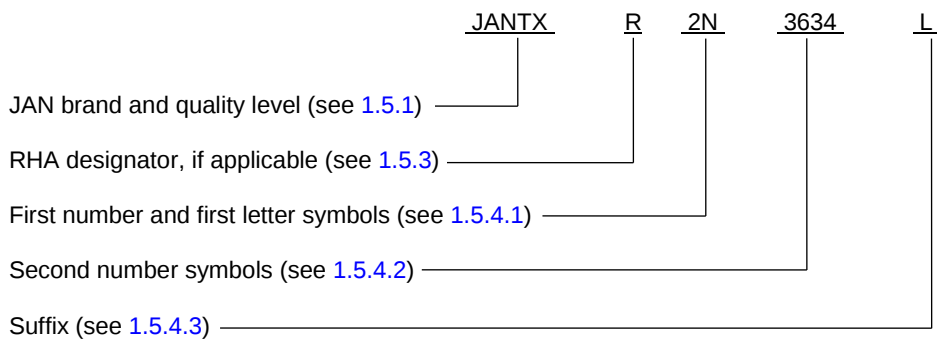
- a. Title, number, and date of this specification.

- f. Surface mount designation if applicable.
- g. For acquisition of RHA designed devices, table II, subgroup 1 testing of group D is optional. If subgroup 1 testing is desired, it must be specified in the contract.

6.3 Qualification. With respect to products requiring qualification, awards will be made only for products which are, at the time of award of contract, qualified for inclusion in Qualified Manufacturers List (QML 19500) whether or not such products have actually been so listed by that date. The attention of the contractors is called to these requirements, and manufacturers are urged to arrange to have the products that they propose to offer to the Federal Government tested for qualification in order that they may be eligible to be awarded contracts or orders for the products covered by this specification. Information pertaining to qualification of products may be obtained from DLA Land and Maritime, ATTN: VQE, P.O. Box 3990, Columbus, OH 43218-3990 or e-mail vqe.chief@dla.mil. 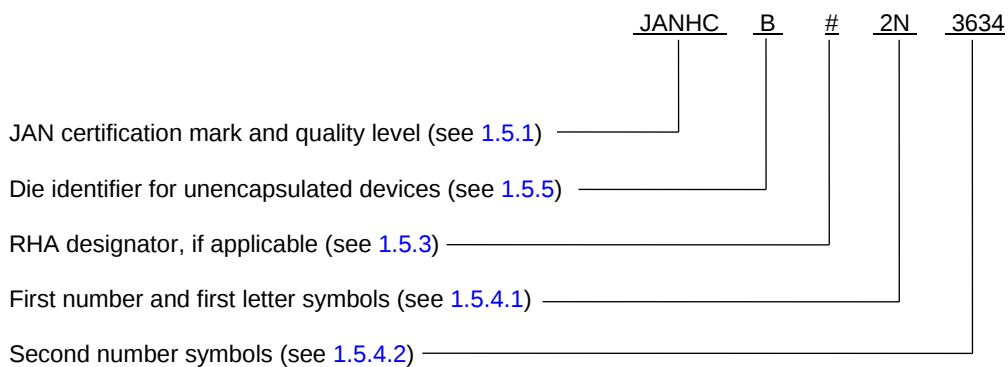
