Subject: Information Regarding Compliance with the Registration, Evaluation, Authorization and Restriction of Chemicals (REACH) for Product Packaging and Shipping Materials

Dear Valued Customer:

Intel is committed to protecting the environment and complying with all hazardous substance regulations. To that end, Intel has surveyed suppliers of product packaging and shipping materials to confirm compliance with laws and regulations that restrict the substance content of product packaging and shipping materials. This letter provides important information about compliance with the European Union's REACH regulation (Regulation No 1907/2006), which addresses the production and use of chemical substances and their potential impacts on human health and the environment.

REACH Article 7 Registration and Notification

At this time, we are not aware of any product packaging and shipping materials used by Intel that would require registration under REACH.

REACH Article 33 (1) Information Obligation

Article 33 (1) requires suppliers to inform the recipients if an article contains more than 0.1% (by weight per article) of any substance(s) on the <u>Substances of Very High Concern (SVHC) Candidate List</u>. The European Chemicals Agency released the latest candidate list of SVHC on **June 14, 2023,** bringing the total number of substances to 235. To the best of our knowledge, none of Intel's product packaging and shipping materials contain any of the SVHC above 0.1% by weight per article.

REACH Article 67 Substance Restrictions

With regard to the requirement of Article 67 of REACH: A substance on its own, in a preparation or in an article, for which Annex XVII contains a restriction shall not be manufactured, placed on the market or used unless it complies with the conditions of that restriction. To the best of our knowledge, none of Intel's product packaging and shipping materials contain any substances subject to any Annex XVII restrictions.

The information provided regarding the substance content of our product packaging and shipping materials is true and correct to the best of our knowledge. If you have any questions concerning this letter, please contact your Intel Representative. We will continue to monitor the status of future REACH SVHC candidate lists as part of our on-going compliance activities.
