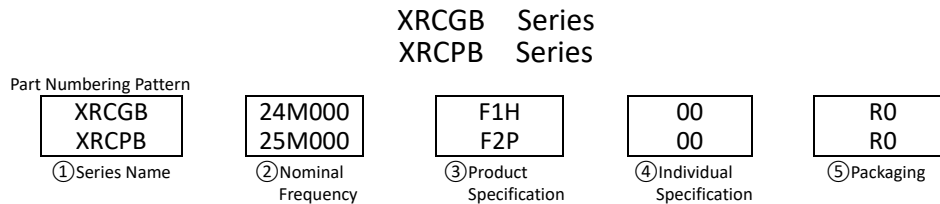


Certificate of RoHS Compliance
