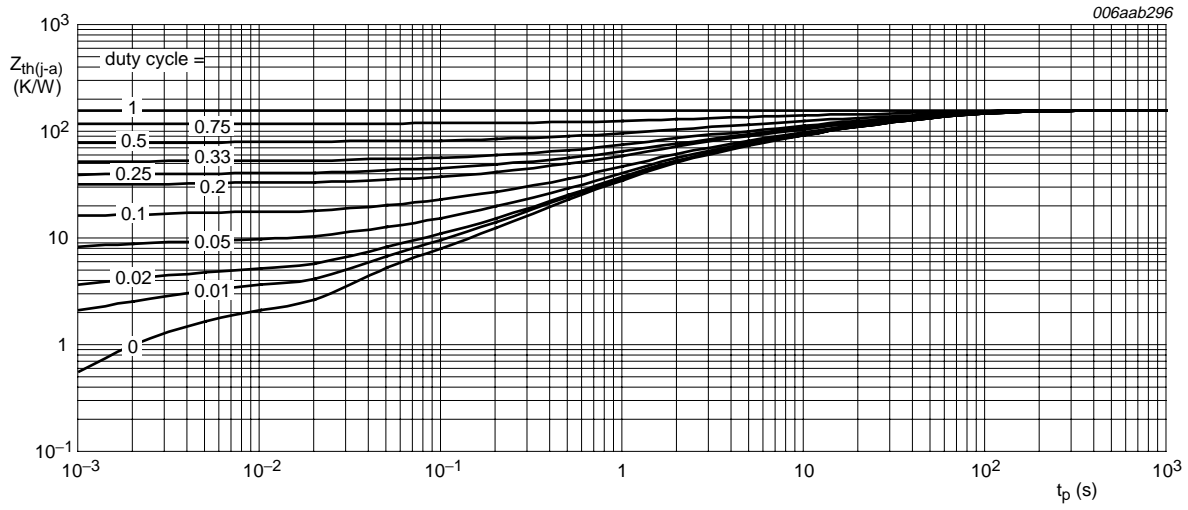

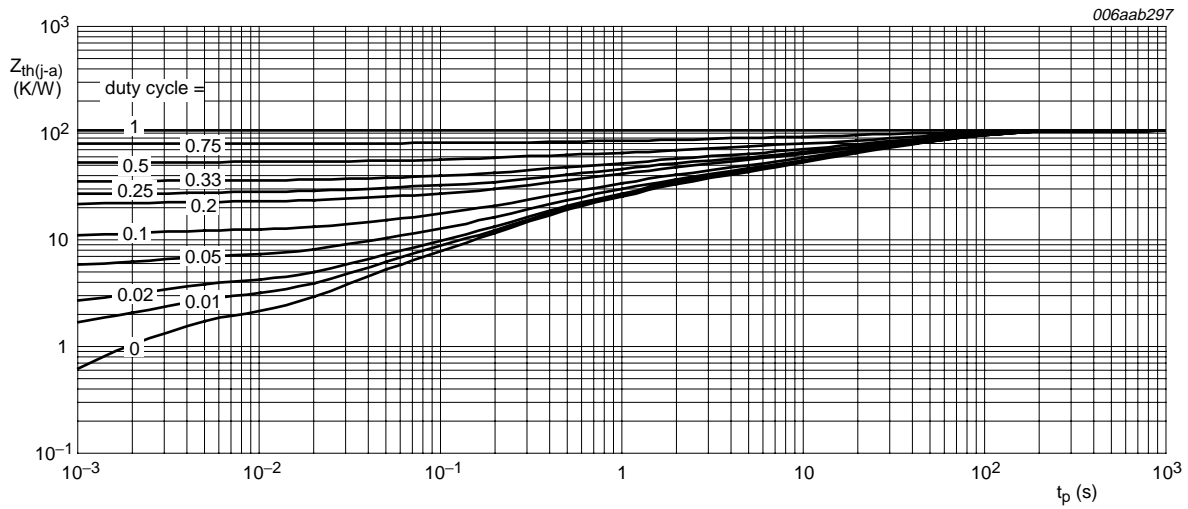

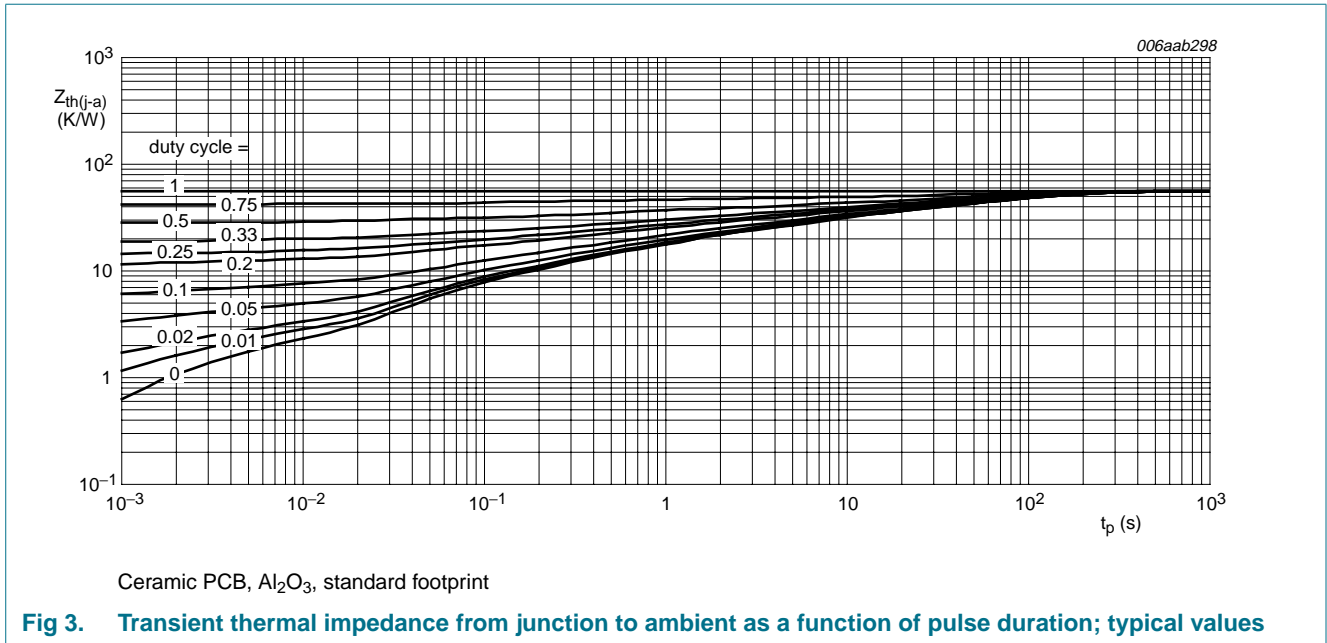
FR4 PCB, standard footprint

**Fig 2. Transient thermal impedance from junction to ambient as a function of pulse duration; typical values**

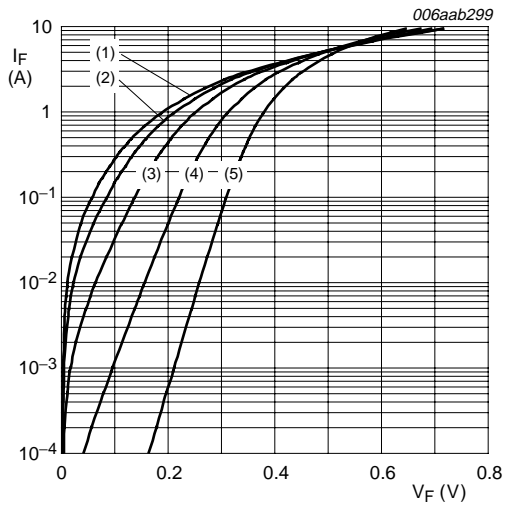

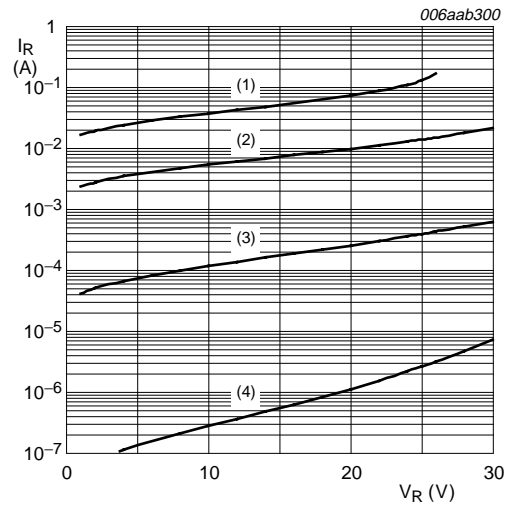

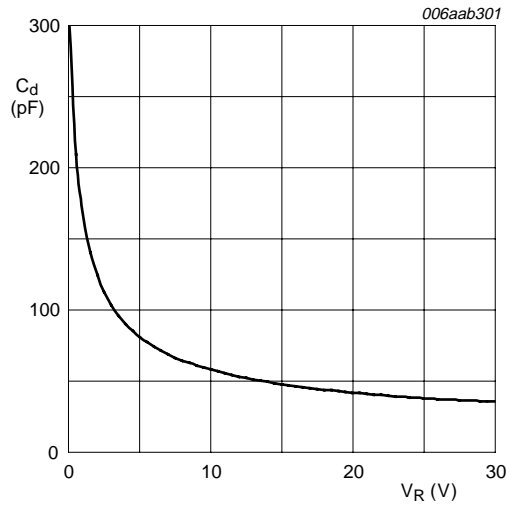

**Fig 4. Forward current as a function of forward voltage; typical values**



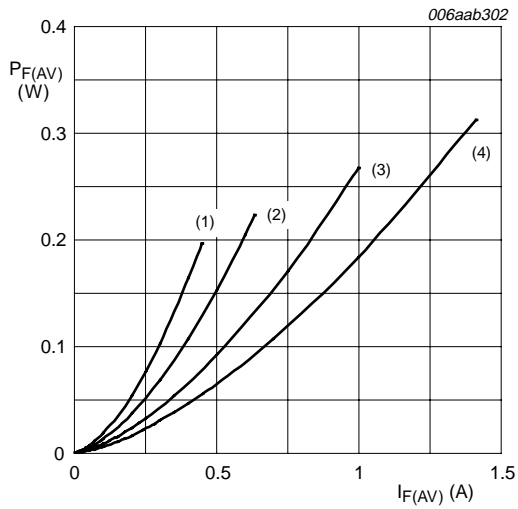

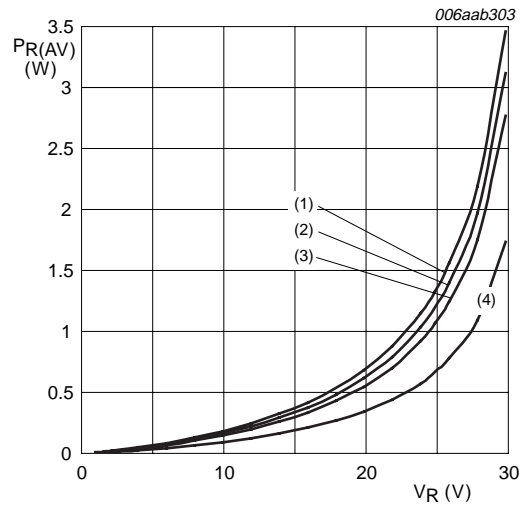
**Fig 6. Diode capacitance as a function of reverse voltage; typical values**

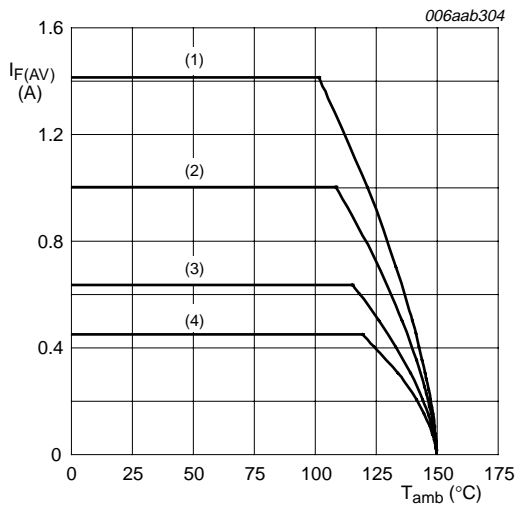
**Fig 7. Average forward power dissipation as a function of average forward current; typical values**

**Fig 8. Average reverse power dissipation as a function of reverse voltage; typical values**

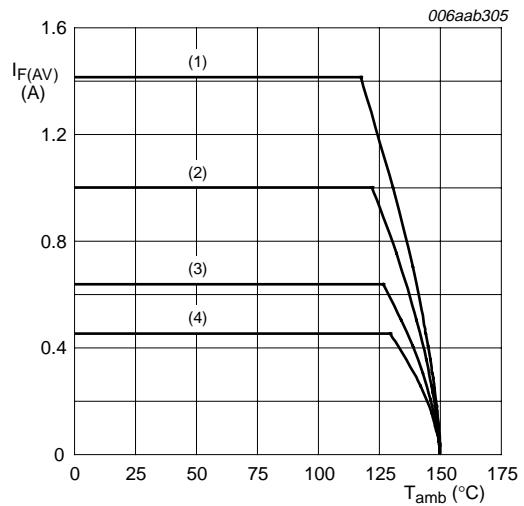

**Fig 9. Average forward current as a function of ambient temperature; typical values**



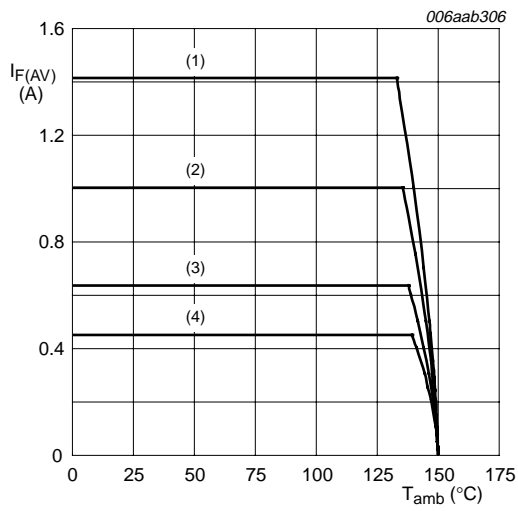

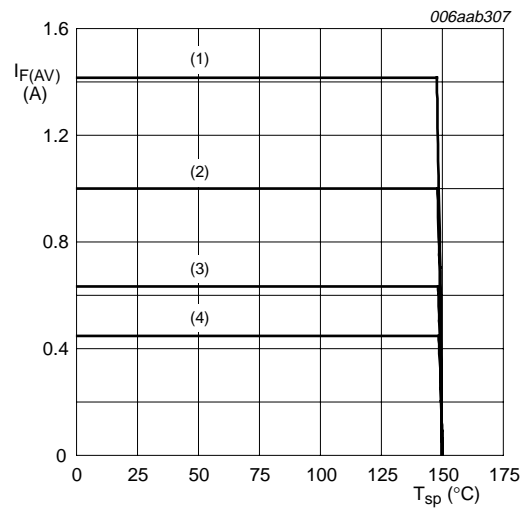
**Fig 10. Average forward current as a function of ambient temperature; typical values**

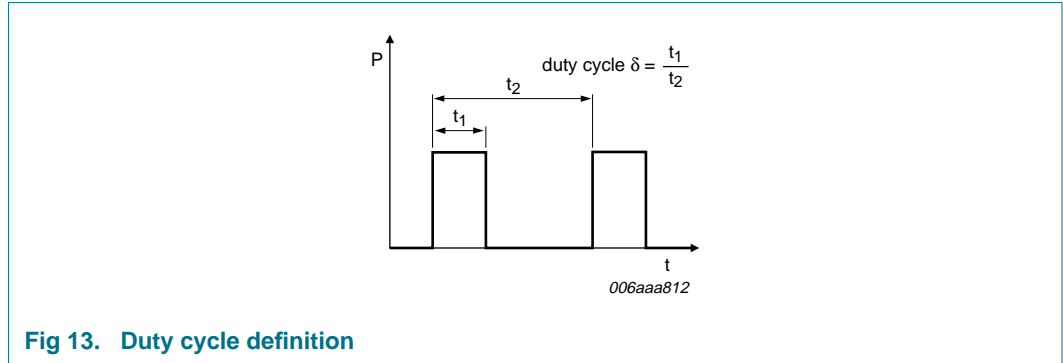
**Fig 11. Average forward current as a function of ambient temperature; typical values**

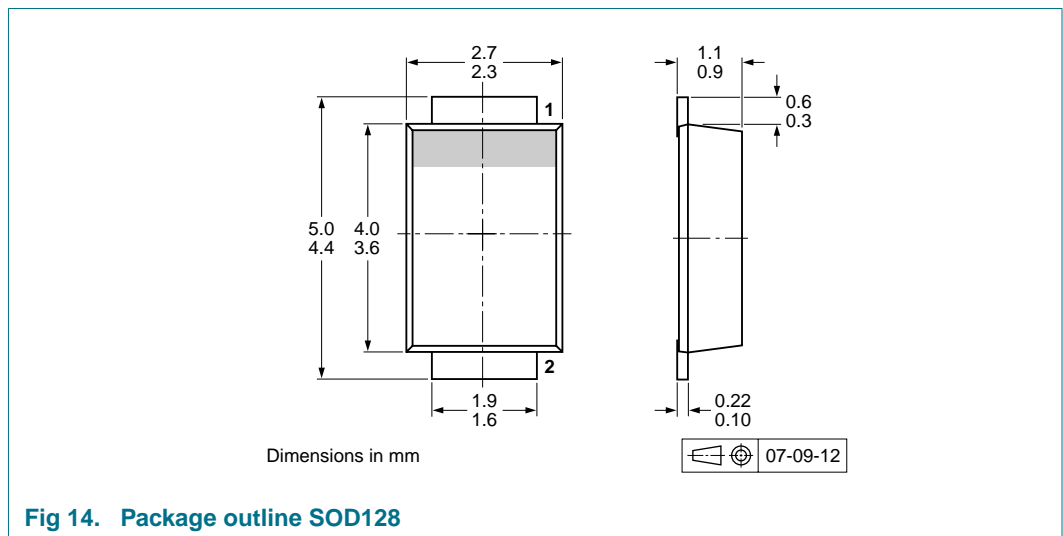
**Fig 13. Duty cycle definition**

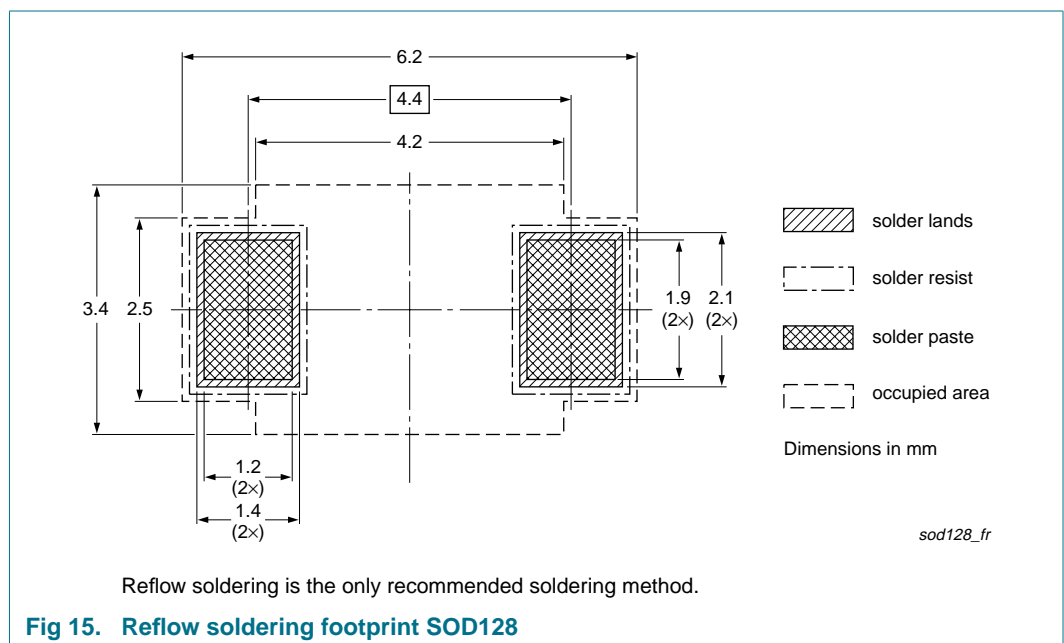
