The 74AHC1G32-Q100; 74AHCT1G32-Q100 is a single 2-input OR gate. Inputs are overvoltage tolerant. This feature allows the use of these devices as translators in mixed voltage environments.








## 11.1. Waveform and test circuit



#### The input (A and B) to output (Y) propagation delays Fig. 5.






Fig. 8. Package outline SOT753 (SC-74A)
