






# Collector-Emitter Capacitance 2), 3)



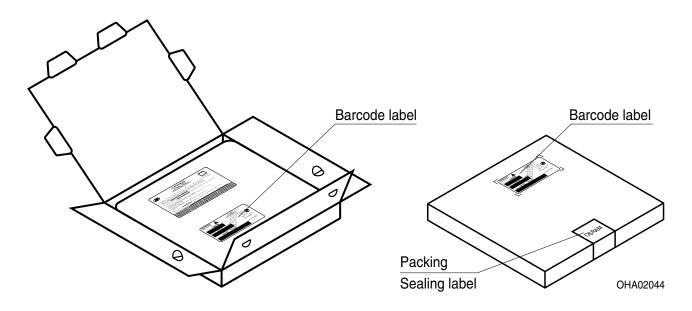
