

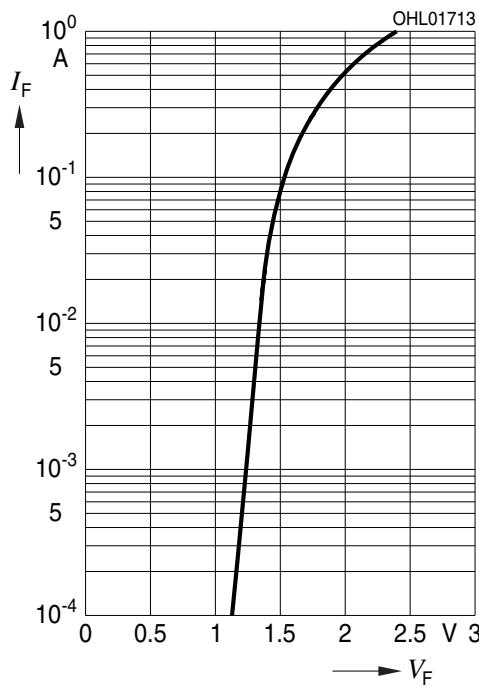

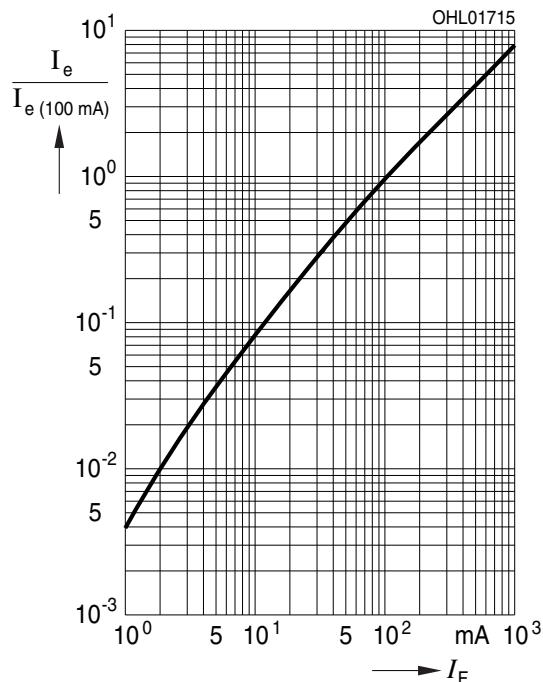





Dimensional Drawing ⁶⁾






