


Relative Spectral Emission 5)


Radiation Characteristics ⁵⁾






Max. Permissible Forward Current

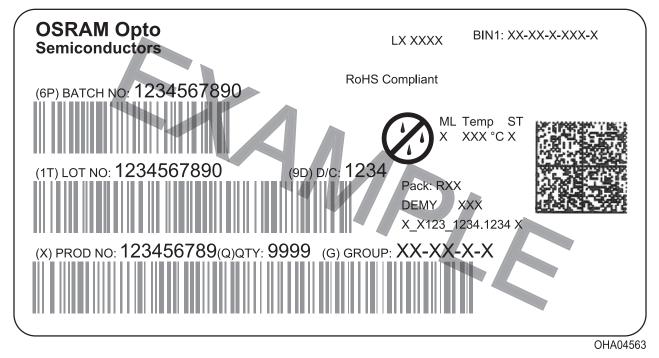
