







Electrical Internal Circuit



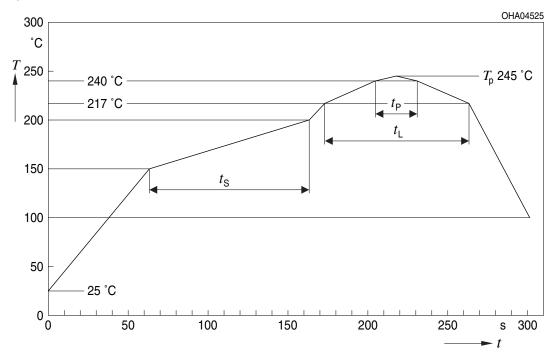
Pins 1: Substrate potential, isolated from Cathode and Anode






Schematic Transportation Box 7)

- Wavelength: The wavelength is measured during a pulse train of 100 ms with a pulse width of 500 μ s and a frequencey of 1 kHz, with an internal reproducibility of \pm 0,5 nm and an expanded uncertainty of \pm 1 nm (acc. to GUM with a coverage factor of k=3).
- Typical Values: Due to the special conditions of the manufacturing processes of semiconductor devices, the typical data or calculated correlations of technical parameters can only reflect statistical figures.
