## Declaration concerning Directive 2011/65/EU (RoHS II)

Hereby you receive information on the compliance with the material requirements of Directive 2011/65/EU<sup>1</sup>.

For the part number related information, please refer to the Excel file "EU\_RoHS\_55A".

The information is based on our current state of knowledge for which we in particular use the specifications provided by our suppliers and service providers. With regard to the exemptions, we are still having an intensive exchange with our suppliers. In this context we would like to point out, however, that we are presently still making use of applicable exemptions in some Phoenix Contact products with electronic components, such as no. 6 et seq. for plug and screw connection elements as well as exemptions no. 7 et seq. and no. 8b for several Phoenix Contact products using electronic components.

For most of our products, a CE marking and EU declaration of conformity according to RoHS II are not required. For products which are already CE marked due to other applicable directives the EU declaration of conformity does not necessarily have to be extended by RoHS II. Only upon expiry of the statutory transitional periods as of 22.07.2019 an update might become necessary.

All products that meet the material requirements are marked in the E-Shop and on the outer packaging. The RoHS pictogram has been revised and already been partially converted.



If products still have the pictogram with the lettering "RoHS WEEE Compliant", this represents stock material. The pictograms serve as a guideline, do not represent an assurance of properties and do not signal an incorporation of RoHS II into the EU declaration of conformity.

The extension of banned substances (phthalates: DEHP, BBP, DBP, DIBP) in accordance with 2015/863/EU shall be applicable from 22 July 2019 at the earliest. We are already working on the revision of the product portfolio to ensure the requirements according to the applicable transitional periods.
