The following Phoenix Contact products have been modified. Existing specifications will be met or exceeded. Please review and acknowledge this document and inform your personnel as needed.

Description for Product Change Notification

Panasonic has made the decision to discontinue the production of a series of their Valve Regulated Lead Acid (VRLA) battery cells. This will affect a few of the battery assemblies manufactured by Phoenix Contact. Phoenix Contact will be replacing the Panasonic batteries used in those assemblies with batteries from BB Battery and YUASA.

The capacity of module 2866417 will be reduced from 1.3 Ah to 1.2 Ah
The capacity of module 2866569 will be reduced from 2.6 Ah to 2.4 Ah,
The capacity of module 2866349 will be increased from 3.4 Ah to 4.2 Ah
The capacity of module 2866352 will be reduced from 7.2 Ah to 7.0 Ah.
The capacity of modules 2866365 will remain unchanged.
The decreases in capacity are only slight and will have no impact on backup times. offered by these modules.

The service life of modules 2866417 and 2866569 will be reduced from 6 - 9 years to 3 - 5 years and ABS approval will not be extended to the new battery cells.

The change will be a running change. As our manufacturing depletes existing inventory of Panasonic cells, the switch over to BB and Yuasa will happen in constant flow of production. The production change will be denoted by an increase the revision level of the device.
