


Connector pin assignment, connection side



Derating diagram

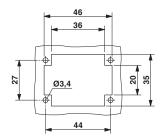
