1. General description

The 74HC08; 74HCT08 is a quad 2-input AND gate. Inputs include clamp diodes. This enables the use of current limiting resistors to interface inputs to voltages in excess of V_{CC} .




Fig 1. Logic symbol




Fig 2. IEC logic symbol




Fig 3. Logic diagram (one gate)





Fig 4. Pin configuration SO14 and (T)SSOP14








Fig 8. Package outline SOT108-1 (SO14)




Fig 9. Package outline SOT337-1 (SSOP14)




Fig 10. Package outline SOT402-1 (TSSOP14)




Fig 11. Package outline SOT762-1 (DHVQFN14)
