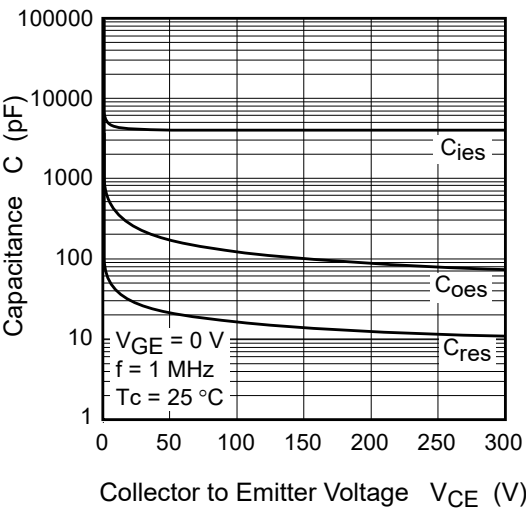

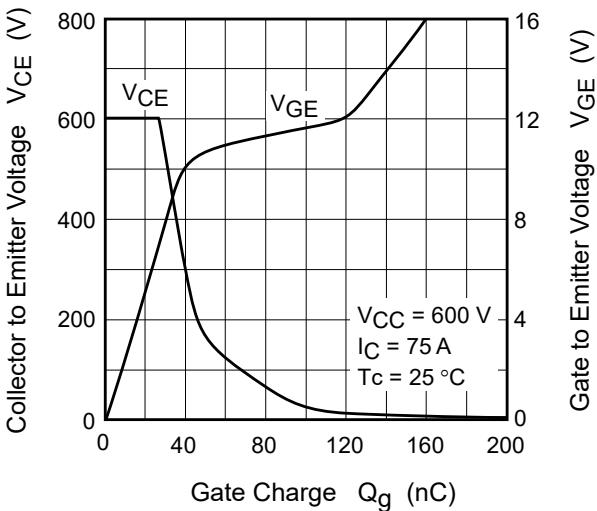


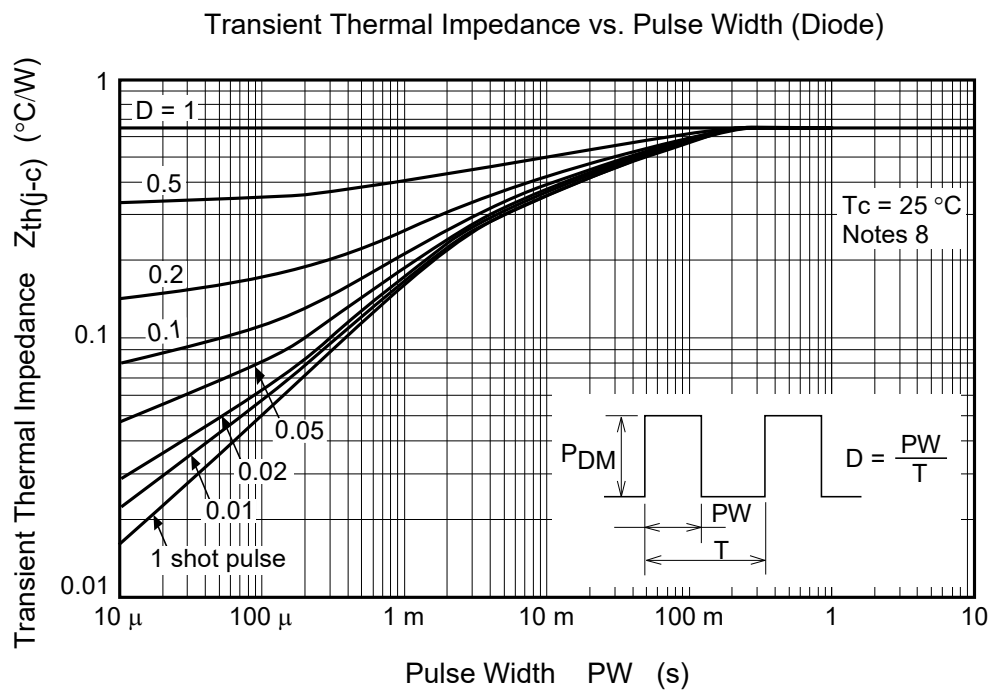
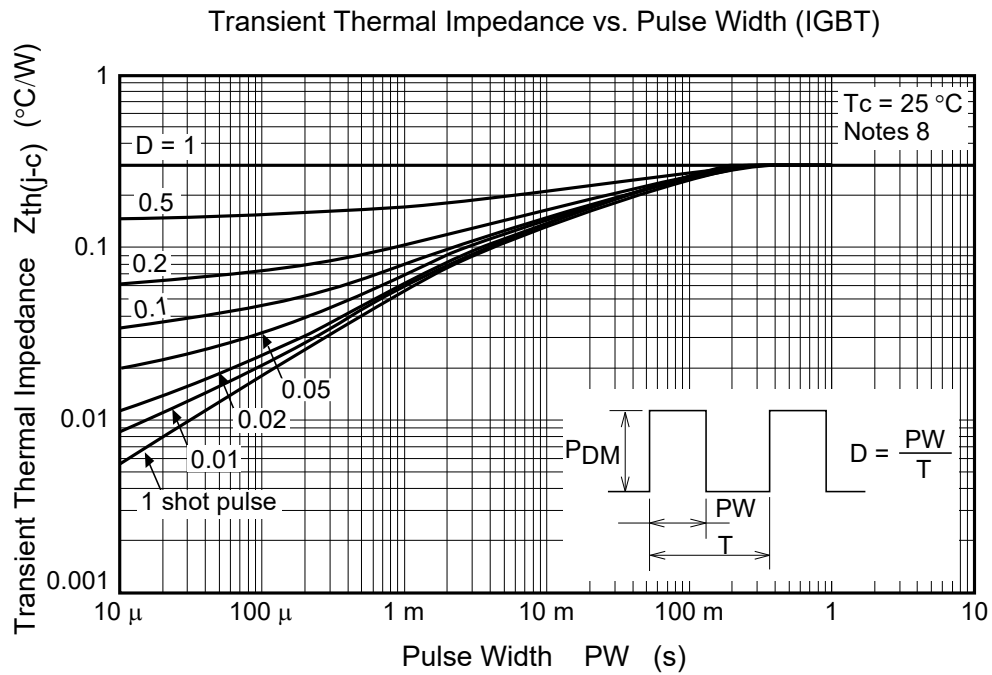


Typical Capacitance vs.
Collector to Emitter Voltage



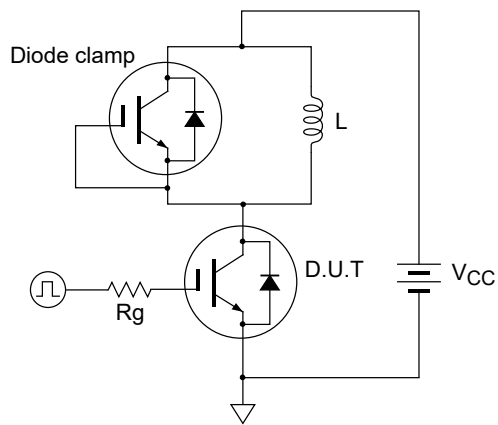
Dynamic Input Characteristics (Typical)



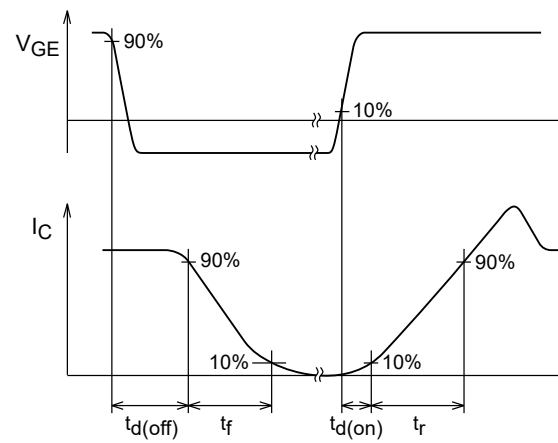

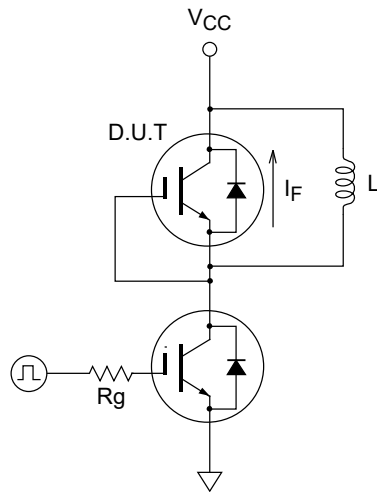
Switching Time Test Circuit



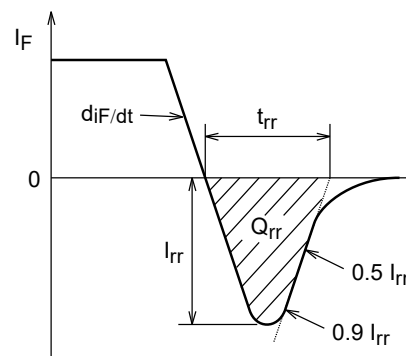
Waveform



Diode Reverse Recovery Time Test Circuit



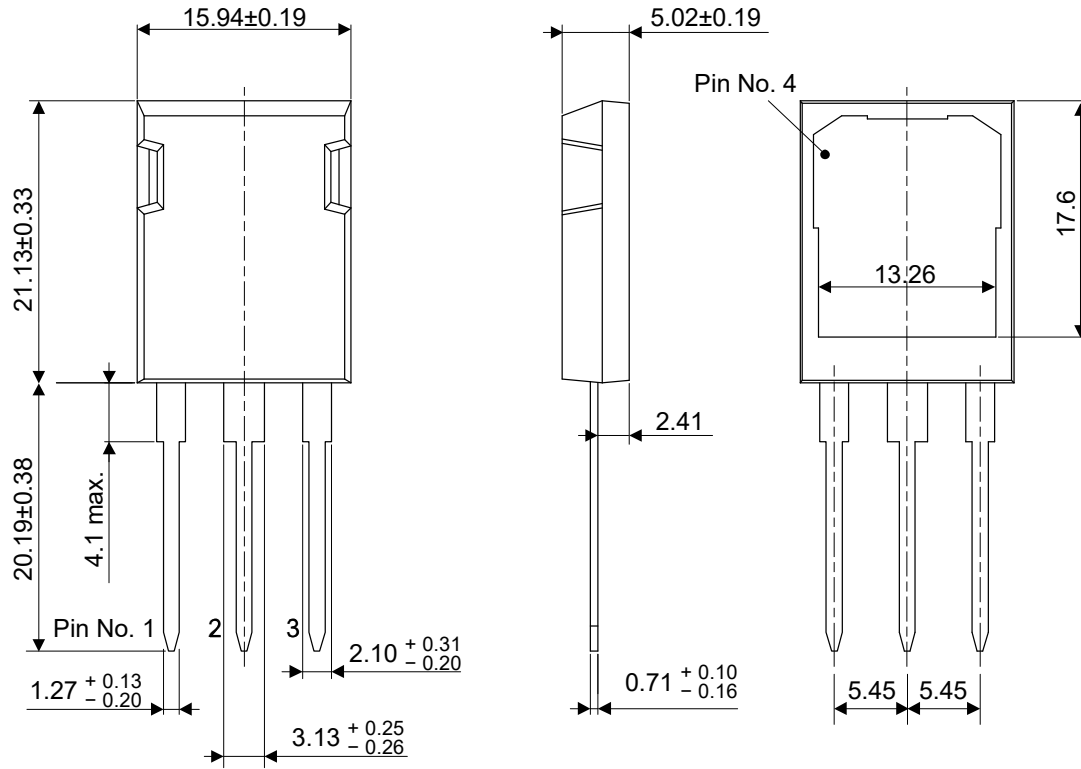
