



•Electrical characteristic curves (T_a = 25°C) <For DTr1 and DTr2 in common>








Fig.2 Output Current vs. Input Voltage (OFF Characteristics)

Fig.4 DC Current Gain vs. Output Current




Fig.3 Output Current vs. Output Voltage


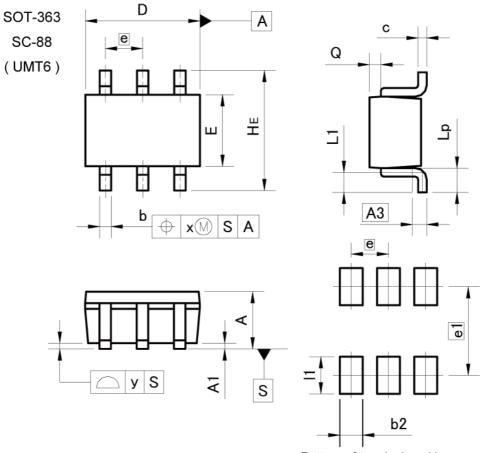


Fig.5 Output Voltage vs. Output Current
