





Fig.1 Ground Emitter Propagation Characteristics

Fig.3 DC Current Gain vs. Collector Current (I)






Fig.4 DC Current Gain vs. Collector Current (II)








# Fig.5 Collector-Emitter Saturation Voltage vs. Collector Current (I)


# Fig.6 Collector-Emitter Saturation Voltage vs. Collector Current (II)





Fig.9 Gain Bandwidth Product vs. Emitter Current
