




Fig. 6.2.1 Switching Time Test Circuit




Fig. 7.1 Marking




Fig. 8.1 I_D - V_{DS}




Fig. 8.3 I_D - V_{GS}




Fig. 8.5 V_{DSS} - T_a




Fig. 8.2 I_D - V_{DS}




Fig. 8.4 VDS - VGS




Fig. 8.6 R_{DS(ON)} - I_D






Fig. 8.7 R_{DS(ON)} - T_a





Fig. 8.9 C - V_{DS}




Fig. 8.8 IDR - VDS




Fig. 8.10 V_{th} - T_a




Fig. 8.12 Eoss - V_{DS}






Fig. 8.13 r_{th} - t_w (Guaranteed Maximum)




Fig. 8.14 E_{AS} - T_{ch} (Guaranteed Maximum)




Fig. 8.16 Test Circuit/Waveform




Fig. 8.15 P_D - T_c (Guaranteed Maximum)




Fig. 8.17 I_D - T_c (Guaranteed Maximum)





Fig. 8.18 Safe Operating Area (Guaranteed Maximum)
