The 2nd source is a PBT GF20 similar to the current material used in production for the housing component. These PNs are TE proprietary designs, therefore considered catalog/general market product. If PPAP is requested, a disposition response is required within 14 days of the submit date or it will be considered approved. Customer product drawing(s) are not affected by this change.

Due to the recent resin shortages due to force-majeure; we hereby inform you of our decision to use an alternate 2nd source PBT GF20 material for the products mentioned within this notification. The alternate material being similar in type with the currently used in production does not impact fit, form and function and parts made of this material are interchangeable with the existing design assemblies.
