Reason: Product improvement. Dear customer, we are contacting you to notify you of a small change to the DT plug connector family. This change is necessary to facilitate the automatic assembly process. While there is a small impact to part form, the fit and function of the part are not impacted. Both configurations of the part function the same previous revision parts are not obsolete and may be used in addition to the new revision. Shipments of bump and non-bump parts may be mixed. IMPORTANT: This is a continual improvement so the current and previous revisions of these parts can be used interchangeably in the field. These changes are being phased-in gradually and previous revision can remain stocked until use.
