This additional capacity will deliver manufacturing contingency and process enhancements. Products manufactured with the additional capacity will be qualified to the same TE release specification RW-3006. The implementation of the new capacity follows a TE internal strict procedure, which maintains quality, ability to supply and form-fit-function as specified by TE of the products within this notification. The manufacturing location operates under an ISO/TS-16949 certified quality management system in accordance with standard automotive requirements.

Reason: Product improvement. TE Connectivity believes this additional capacity of manufacturing will not affect the form, fit or function of the products as specified by TE Connectivity.
