The mold used to create some of the plastic housings used in the part numbers below is moving from a TE supplier based in Hermosillo, Mexico to a TE manufacturing plant also based in Hermosillo, Mexico. The housings moving are the 207055-1 Back Shell Extender used in the 207052-3 Jacketed Cable Seal Kit as well as the 206205-1 Cable Clamp Body used in the 206138-8 and 1-206138-0 Cable Clamp Kits. Note: This PCN supersedes PCN P-16-013429 distributed 10Aug2016.
