TE Connectivity will be adding an additional manufacturing source for the PCB wafers used in MULTIGIG Backplane Connectors

Reason for Changes:

TE Connectivity manufactures the MULTIGIG RT 2 and MULTIGIG RT 2-R product offerings to support high speed signals in the VPX embedded computing architecture segment. The product has been tested to support applications that require extreme vibration levels and have been widely adopted in the Military/ Aerospace market place. The markets served where the TE Connectivity MULTIGIG RT-2 & MULTIGIG RT2-R are being specified continue to grow and we are anticipating increased demands in the future.
