Subject: DEUTSCH DT plug - 8 pin

Description of Change: The Industrial and Commercial Transportation (ICT) business unit of TE Connectivity (TEC) intends to implement a change to the DT8 pin plug front seal (1010-007-0806) to improve sealing robustness. The inside width and length will decrease approximately 4% and 5%, respectively. Also, the amount of silicone phenyl fluid will reduce from 1.75% to 0.50%. PPAP package will be offered by customer request once a sufficient inventory bank is built to prevent any delay. DT8pin product drawings are not affected, however see attached for 1010-007-0806 prerelease product drawing.

Reason: Product Improvement. Dear Customer, we inform you of this change as part of our aggressive continuous improvement efforts. The change has minimal effect on form and does not affect fit or function. The change has been validated with manufacturing and laboratory testing. The change will be managed by TEC TS16949 quality procedures. An internal release based on our specifications will be executed before any parts are delivered. IMPORTANT: This is a continual improvement so the current and previous revisions of these parts can be used interchangeably in the field. This change is being phased-in gradually and the previous revision can remain stocked until use.
