Description of Change: The pigment for the Orange colorant in the molded plastic housings is being replaced by an equivalent substitute product. This replacement colorant formulation has completed TE validation testing. Both the current and replacement orange colorants meet the RAL2008 color code standard. There is no impact to the FFF of the listed end assembly/customer part numbers. Dimensionally, physically and functionally the parts will be the same as current product. There will be no change to the part numbers or revision. TEC will track the changeover internally on the manufacturing print at the component level, and will implement as a running change.

Reason: New specification. The supplier for the orange pigment has discontinued manufacture due to commercial reasons.
