Following drafting errors are corrected only in the drawing. 1) Dimension L for parts 2141868-1, -2 and -3 are changed in only in the table of drawing from 15.3 to 16.3mm. 2) Rev of 1718762-1, -2 and -3 are corrected in the table to B, C and B respectively.

Document Clarification. Parts 2141868-1, -2 and -3 are manufactured for dimension 16.3mm from the beginning but wrongly mentioned in the drawing as 15.3mm. Also, revisions were mentioned incorrectly for parts 1718762-1, -2 and -3 in the drawing. These drafting errors/ mistakes are corrected through this PCN.
