**Description of Change:** The Box carton and reel will change to use standard automotive AIAG shape and size. The AIAG box carton allows more reels per box. AIAG reel has flats on the cardboard sides permitting slightly less quantities per reel than previous reels. Reel quantities will change to 3200, (was) 4000. Box carton will contain 5 reels x 3200 pieces/reel (16,000 pieces), whereas previous box carton has 4 reels x 4000 pieces/reel (16,000 pieces). Minimum Order Quantity (MOQ) will remain the same.(Ref PCN :E-Ref PCN :E-17-004843)

**Reason:** Dear customer, we are informing you of this process change to the way the below part number(s) are packaged. These changes will conform to automotive packaging standards and will improve the quality of the outermost windings of terminals. The only change you will notice is the way the product is packaged. This change does not affect fit, form or function of the product. **IMPORTANT:** This is a continual process. These changes are being phased in gradually and previous reel and box versions can remain stocked until use. Shipments of multiple boxes may contain both packaging options. The product drawings or application specifications are not affected.
