DEUTSCH Size 16 Stamped and Formed Socket Terminals.

Description of Changes

The Box carton and reel will change to use standard automotive AIAG shape and size. The AIAG box carton allows more reels per box. AIAG reel has flats on the cardboard sides permitting slightly less quantities per reel than previous reels. Reel quantities will change to 3200, (was) 4000. Box carton will contain 5 reels x 3200 pieces/reel (16,000 pieces), whereas previous box carton has 4 reels x 4000 pieces/reel (16,000 pieces). Minimum Order Quantity (MOQ) will remain the same.(Ref PCN :E-Ref PCN :E-17-004843)
