TE Connectivity has been informed by VDE that our certification has expired on the Unfiltered P-Series product.

<b>Description of Changes</b>
TE Connectivity has been informed by VDE that our certification has expired on the Unfiltered P-Series product. This only impacts the unfiltered version of the P-Series manufactured after October 31st 2017 (Lot Code 1744) and as a consequence we will temporarily be removing the VDE logo on our product label for all Unfiltered P-Series configurations. All remaining Filtered P-Series product configurations are not impacted. We expect this to be temporary and are addressing this issue through an active project at VDE.

<b>Reason for Cancellation:</b>
October 15, 2018. VDE has reinstated approvals on the Unfiltered P Series. TE will supply products with the VDE Mark.
