Subject: Size 16 Stamped and Formed Pins Manufacturing Location Change

Description of Change: The Industrial and Commercial Transportation business unit of TE Connectivity is adding a manufacturing location and transferring one tool capable of producing the Size 16 stamped and formed pin part numbers listed below from USA to China (Tool ID 6). Remaining tools will be unaffected. This change affects only customers in China. Shipping point will change to TE Suzhou for these affected customers. These PNs are TE proprietary designs, therefore considered catalog/general market product. PPAP and/or sample requests must be submitted within 14 days of PCN submission via ict-ppap-request@te.com or TE e-PPAP system. Submissions will not occur without request. If PPAP is requested, disposition response is required within 14 days of submit date or it will be considered approved.

Reason: This change is necessary for alignment of overall manufacturing capacity and footprint to better meet our Customer's needs. IMPORTANT: The change will not impact fit or function. The only change to the FORM is a circle added around the Tool ID on the back of the part to signify the part originated in China. See picture below.
