The Industrial and Commercial Transportation business unit of TE Connectivity is making a change to the gap between the locking shoulder and wire crimp barrel for the part number(s) listed below. NOTE: The distance from the locking shoulder to the wire crimp barrel has not changed nor the overall length of the terminal. These PNs are TE proprietary designs, therefore considered catalog/general market product. PPAP and/or sample requests must be submitted within 14 days of PCN submission via [ict-ppap-request@te.com](mailto:ict-ppap-request@te.com) or ePPAP system. Submission will not occur without request. If PPAP requested, disposition response is required within 14 days of submit date or it will be considered approved. The change does not impact performance and crimp application tooling. Product drawing(s) are affected.

REASON FOR CHANGE: The change is necessary to align the design with other size 16 S&F pin terminals. IMPORTANT: The current and previous revisions of these parts can be used interchangeably in the field. The change(s) are being phased in gradually and previous revision can remain stocked until use. Shipments of both configurations may be mixed.
