The flammability rating on the newly approved wedge lock material is V-0 while the current one is HB. The current and the new raw materials are PBT 30GF. Change does not affect fit, form and function. **IMPORTANT:** The current and previous revisions of these parts can be used interchangeably in the field. The change is being phased in gradually and previous revision can remain stocked until use.
