This review has resulted in our decision to reduce the tin plating thickness on selected part numbers from the current requirement to 40 micro inches minimum. Other than thickness, no change is being made to the tin plating [specification](#). It is also important to note that TE Connectivity offers several other industry accepted product families that have plating thicknesses in the 20-40 microinch range.
