**Description of Change:** Manufacturing location change. All the current Ampseal 16 assembly lines including automated, semi-automated, and manual assembly equipment, as well as all molding presses and molds located at the TE Automotive Plant #1 and #4 in Empalme, Mexico will be transferred to the TE ICT Plant #3 located only a few hundred feet away in the same campus (see attachment). All current resources will transfer with the equipment to maintain continuity and familiarity. This building already successfully manufactures a sizable amount of ICT Products.

**Reason:** The reason is to consolidate all the Ampseal 16 components and assembly operations into the state of the art building for improved focus on quality and delivery of product. The transfer follows a strict procedure, which fully maintains quality, ability to supply, and form-fit-function. The new manufacturing location operates under a certified quality management system in accordance with standard automotive requirements. The move of the molds and mold presses will begin February 2018 and will continue through September 2018 with several connector families moving every month. Premove and post-move QIP/Critical dimensions will be measured for each mold move.
