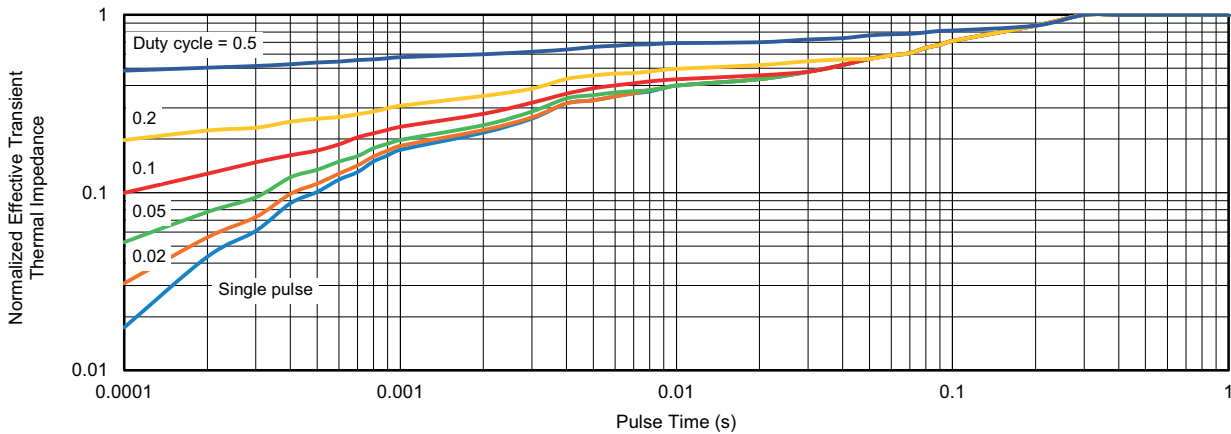
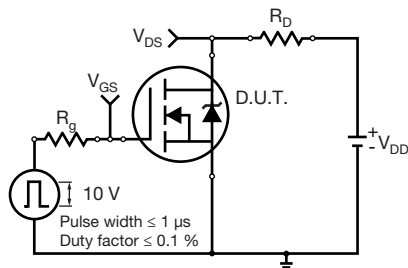
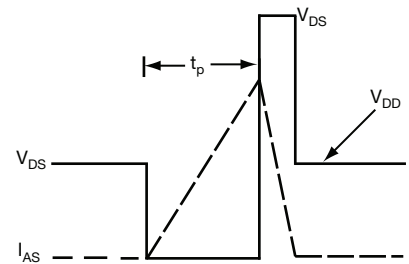
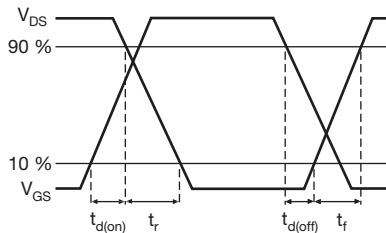
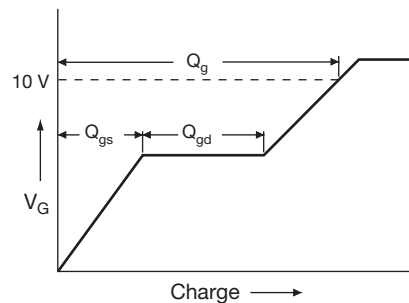
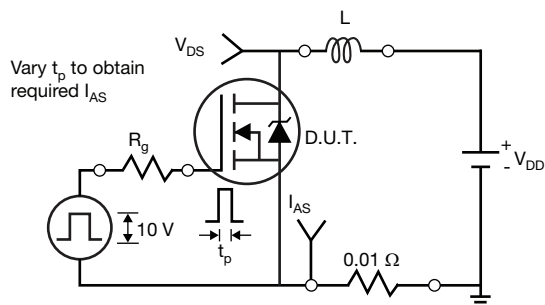
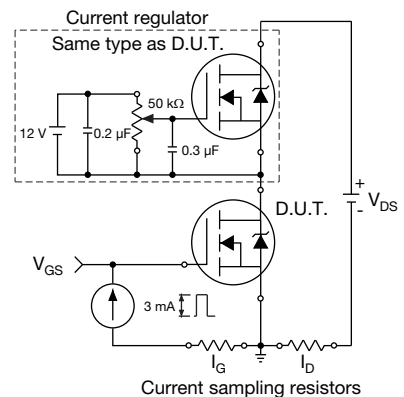

Fig. 12 - Normalized Transient Thermal Impedance, Junction-to-Case

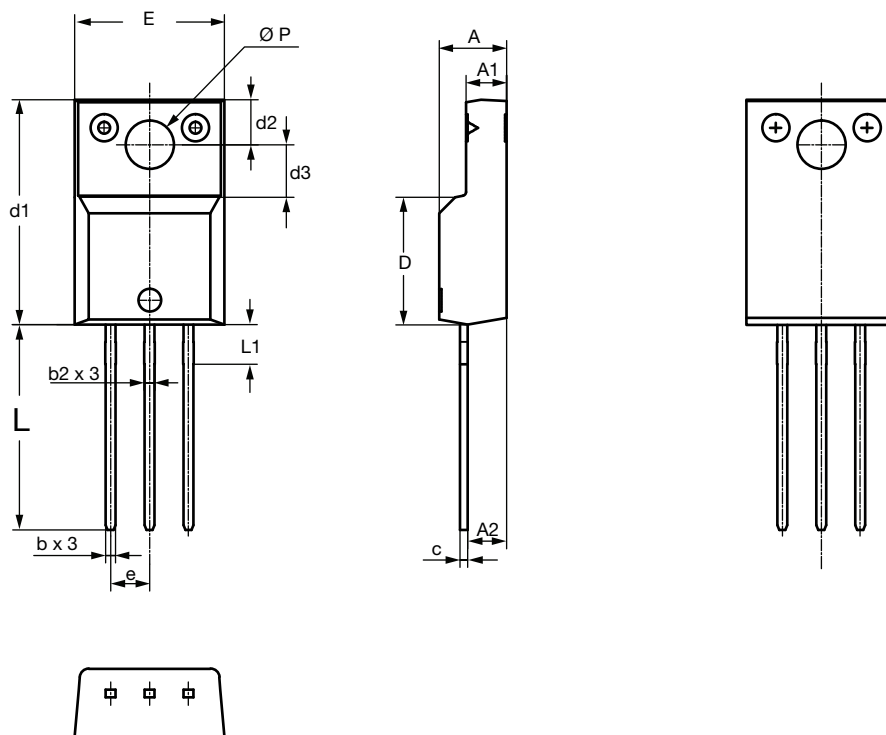


Fig. 19 - For N-Channel
