






TYPICAL CHARACTERISTICS (T_A = 25 °C, unless otherwise noted)






On-Resistance vs. Gate-to-Source Voltage

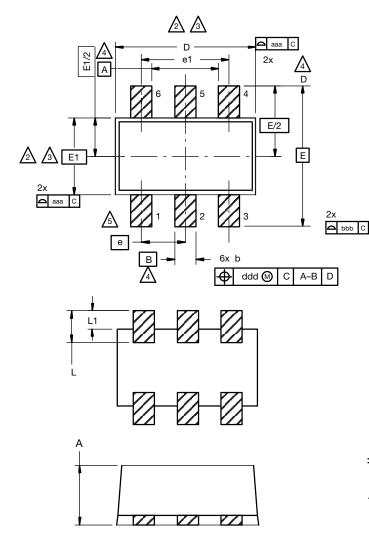
