


Figure 1. Max. Reverse Power Dissipation vs. Junction Temperature




Figure 3. Forward Current vs. Forward Voltage




Figure 2. Reverse Current vs. Junction Temperature




Figure 4. Diode Capacitance vs. Reverse Voltage









Figure 5. Board for R<sub>thJA</sub> definition (in mm)
